Next meeting due to take place in August to discuss future steps. Catherine Smith of Medway Council has shown an interest and would like to attend the next meeting. Surveys online will continue for another month and half. Cllrs are urged to encourage Parishioners to complete residents' survey online in order to gain a clearer vision for the neighbourhood plan. Residents' survey will be analysed and findings circulated. The initial responses show a cleat concern about traffic speed and volume of HGVs (mainly B2000) and then parking. There was also a clear need to 'protect' the parish area from development where possible and control it where not.

Over half a million people responded to the RSPB Defend Nature campaign, the largest response ever received by an EU consultation.
