Minutes of the Elkesley Parish Council meeting held on Tuesday 20<sup>th</sup> November 2018, at 7.00pm in the Elkesley Memorial Hall, High Street, Elkesley.

- **3068/18 To receive apologies for absence** Apologies received and approved from Cllr Oldbury, Cllr May, Cllr Woodcock and Cllr Wilkinson; it was noted that Cllr Fish will join the meeting later.

## **3069/18** To receive and record declaration of interests from Members in any agenda item to be discussed

No declaration of interests received.

**3070/18 To suspend the meeting to hold a 10 minute public session** The meeting was suspended to allow members of the public to speak. No questions were asked.

#### **3071/18** To receive reports from the District and County Councillors

#### County Cllr Kevin Greaves reported:

He has put in a request for dropped kerbing on Beech Walk after a request from Cllr Oldbury; the missing gullies have been replace, the leaning lamp post has been reported and he will chase up the repair to the faulty bollard on the bridge roundabout. Little is happening at County at the moment; people are wrapped up with the Unitary Council issues at the moment. 2,600 replies were received from the consultation regarding the Unitary Council; this is out of the 88,500 population.

The Chancellor has allocated £40m towards roads; Notts County Council waiting to hear what their share will be

Notts County Council is also looking into buying Via. Via was created a couple of years ago in coalition with Cornwall; with a view to make a profit that can be put back in to the highways; currently £1.6m profit has been made.

#### District Cllr Kevin Dukes reported:

The District Council is also tied up with the proposed Unitary Council issue. The Bassetlaw's new website is now up and running; which includes links to the Parish Portal where faults can be reported.

A1 Housing has now been brought back into the District Council's control; a new Head of Housing is now in place.

Cllr Stronach raised a faulty litter bin which requires a new liner; Cllr Dukes will report this.

#### **3072/18** To approve the minutes of the meeting held 16<sup>th</sup> October 2018

Cllr Flear proposed to accept the minutes of the meeting held 16<sup>th</sup> October 2018 as a true record; this was seconded by Cllr Stronach and resolved by 4 votes.

# 3073/18 Planning – To consider any planning applications, note any planning correspondence and decision notices

It was noted that revised plans for the Robin Hood Inn have been submitted to Planning; however no formal notification of the revised plans has been sent to the Parish Council – the Clerk will contact the Planning Officer.

#### 3074/18 To receive an update on the Robin Hood Inn

In his absence Cllr Oldbury sent the following information— the Steering Group has reformed and is looking at options; the group will keep updating and consultations will be required.

### **3075/18** To consider the Football Association grants and quotations

Deferred to the next meeting as Cllr May is not present.

#### **3076/18** Proposal to consider options regarding the sports field hedge

Cllr Flear proposed to engage a farmer/contractor to carry out work to the sports field on an hourly rate basis to cover any work as and when required. After discussion Cllr Flear proposed to obtain 3 quotations for the following specification: *To remove at ground level of all trees, shrubs and bushes within the dyke and sports field side and removed.* This was seconded by Cllr Stronach and resolved by 4 votes.

## **3077/18** To receive update on the Christmas tree and lighting event and approve associated expenses

Cllr Flear reported on the quote for a Christmas to be felled and delivered of £350.00 inc delivery; the Clerk suggested an alternative supplier and would be able to send details after the meeting. After discussion Cllr Flear thought he may potentially be able to obtain a donated tree. Cllr Flear proposed that the Council gives approval for him to obtain a donated tree if he is able to get one; otherwise to source and purchase the cheapest tree; this was seconded by Cllr Ffoulkes-Jones and resolved by 4 votes. Other expenses will be the same as last year e.g soup; bread rolls and sweets etc. The Tree lighting will take place on the 2<sup>nd</sup> December after the Christingle finishes at the Church.

#### 3078/18 To receive update on the play shelter repairs and contractor

Deferred to the next meeting; as Cllr Oldbury was not present.

### **3079/18** To consider having a First Aid training session

After discussion; this item was deferred to the next meeting when Cllr Oldbury is present.

Guest speakers were Cllr John Cottee (Chair of Communities and Place Committee at Notts County Council) and Mr Gary Wood (Head of Highways and Transport at Notts County Council). Cllr O'Brien gave a brief report on the presentations that were given.

#### **3084/18** Proposal to consider collaborative working with other groups for the benefit of the village Cllr Oldbury had submitted this proposal; his idea is to meet and talk with other groups and asked if it could be approved to agree that we should take this idea forward. There would be an equal number of people from each group and he would like to be involved. Cllr Flear proposed to take this idea forward; this was seconded by Cllr O'Brien and resolved by 4 votes.
