001/19 Election of Chairman

The Chairman, Cllr Coleman, welcomed everyone to the meeting and explained that she had decided to resign from the Council.

- a) It was proposed by Cllr Golding, seconded by Cllr Smith and agreed that Cllr John Neale be elected as Chairman of the Council for the ensuing year.
- b) Cllr Neale signed the Declaration of Acceptance of Office of Chairman of the Council.

On behalf of the Council, Cllr Neale thanked Councillors Sally Coleman and Robin Thornby for their commitment and valuable contribution to the parish, and wished them all the best for the future

002/19 Election of Vice-Chairman

Cllr Golding offered to continue as Vice-Chairman of the Council for the ensuing year. His offer was accepted unanimously.

003/19 Co-option of Councillors

Following the resignation of two councillors the Council has decided to co-opt two new councillors. Interest in these vacancies has been received from Craig Watt-Peters and Robin Peters, both residents of the parish. Both applicants gave presentations outlining a little about themselves and any skills and experience they feel they can bring to the Parish Council.

- a) It was agreed unanimously to co-opt both applicants to the Council.
- b) Cllr Watt-Peters and Cllr Peters signed the Declaration of Acceptance of Office and Notification of Disclosure Pecuniary Interests forms.

To declare any Disclosable Pecuniary Interests (DPI) and Other Significant Interests (OSI) relating to items on the agenda.

006/19 Matters arising from the above meetings

- a) ElecLink have advised that they will complete their works in the King George V Playing Field in the next three weeks. However, the decision has been taken to cancel the Village Fete this year. The Council is seeking compensation from ElecLink for financial losses resulting from this decision.
- b) The vacancy for Parish Clerk/Responsible Finance Officer has been advertised locally and on the Kent Association of Local Council's website. Three applications were received which included Melvyn Twycross, the current locum Clerk. The remaining two applicants lived some distance out of the parish which would have resulted in considerable travel to carry out their duties within the parish. Mr Twycross lives in the parish and has been employed in the role previously. The Council agreed to offer the post to Mr Twycross which he has duly accepted.

007/19 Public Forum

A resident of the parish complained that the noise throughout the night of a pump operated by ElecLink was unacceptable. Noise reduction measures had been taken by ElecLink but were ineffective. Cllr Golding agreed to report the matter to ElecLink as a matter of urgency.
