3. Shropshire Councillor Martin Taylor Smith:

a) The work had commenced on Ludford Bridge with the first part of the repair involves erecting complex scaffold platform to enable contractors to access the damaged part of the bridge.
It is expected that the work will be completed just before the Easter holiday period however this will involve weekend working.

7. Highway Items:

a) The Clerk reported that a submission had been made to the Ludlow and Rural Local Joint Committee for a grant towards the initial running cost of vehicle activated signs which would be rotated at two different sites Rocks Green and The Sheet, however this will be subject to the Parish Council meeting the one off installation costs being £500 per site and a speed survey being undertaken by Shropshire Council

The running cost of each individual sign is £60 per week with the minimum commitment being two weeks per site on a quarterly basis.

The Parish Council after the initial year will then need to consider if the scheme has been beneficial to the two areas and whether and how to meet future ongoing running costs. It was not possible to place a sign at Ludford as the vehicle activated signs depended on solar power and the trees along the roadway blocked the required sun rays for operation of the signs. The Parish Council approved the initial installation costs of £1,000.

b) The Parish Council are still hoping to obtain signs to indicate Ludford Village for which an offer of a donation had been made for the supply of the sign by Park Road Ludford.

Prior to the Parish Council meeting there was a Public meeting for the presentation by Morris Leisure on proposals for a Touring Caravan Park on land off Overton Road Ludlow which is situated in Richards Castle (Shropshire) Parish Council area. The meeting was attended by 12 members of the public.

The Chairman introduced the representatives of Morris Leisure to the meeting and explained that the meeting had been arranged to enable the public to be made aware of a planning application that will shortly be submitted for the development of a 135 pitch touring caravan site. The Parish Council would not consider the matter until the application had been submitted.

Morris Leisure have an option on 14 ha of land off Overton Road Ludlow on which it was proposed to develop 8ha as a 135 pitch touring caravan site, which does not include static caravans or for traveller accommodation, however touring caravans do include motor homes and tents.

Morris Leisure explained details of the site, screening and access proposals which included discussions with the Highway Agency about improvements to the junction off the A49 and Shropshire Council about improvements along Overton Road.

Morris Leisure outlined the detailed feasibility reports that will be include with the planning application including an appropriate Economic Statement and Transport Assessment/Travel Plan. Meetings are to be held with Ludlow Town Council and an exhibition to be held at the Charlton Arms Ludford on the 4th and 5th February 2011.

The Chairman gave an opportunity for members of the public to ask questions which related to landscaping of the site, the need, access and economic benefit.

There were concerns about the access to the site from Overton Road and the impact on Ludford Bridge and particularly Policeman's Corner.

The Chairman thanked Morris Leisure for their presentation and the members of the public for attending.

2. Shropshire Councillor Martin Taylor Smith:

Martin gave an update on the following items to which the Parish Council also made comments: a) Proposed New Hospital Ludlow – outline planning application will shortly be published, there may also be a separate application for an Ambulance Station based at the Eco Park.

The Parish Council were concerned about the lack of car parking places at the Eco Park site and although this had been pointed out on recent planning applications on the site it appears to have been ignored by Shropshire Council.

- b) The Local Development Framework is expected to be implemented from the 1st April 2011 replacing existing planning policies.
- c) Ludford Bridge anticipated that repair work will take place in March and could take six to eight weeks to complete.

The Parish Council confirmed that it wanted an appropriate weight limit put on the bridge and the Clerk was asked to write to Shropshire Council.

d) Martin reported on the various budget cuts being considered by Shropshire Council with £76 million now having to be saved over the next four years, this will see a reduction in some services for example Libraries, Social Services Helena Lane Ludlow, Closure of Public Conveniences, Concessionary Fares Scheme and Bus services.

- c) Concern site is Unimaginative suggest reclaimed red clay tiles would be a preferable roofing material to the proposed interlocking concrete tiles since they would help emphasise the domestic nature of the development ,as well as blending more harmoniously with the two nearest buildings, the Travel Lodge to the north and the Grade II Listed Foldgate Farmhouse to the south-west.
- d) Should preserve the rural nature of Foldgate Lane as a valuable residential amenity, the retention of the existing earth banks to the south and south-west of the site, and suggest that the existing hedge between the development and Foldgate Lane be thickened by further planting of native species along its length, and maintained at a height of at least three metres, as at present."

- a) Local residents had contacted Shropshire Council concerning large vehicles turning into Lower Barns Road assuming that it is the access road to Lower Barns Business Park. It has been suggested that a large sign be placed at the entrance to the site indicating "No through Road" with a directional sign showing access by the Auction Yard. The Parish Council agreed to support the request.
- b) Shropshire Council would not consider an extension of the existing 30mph speed limit southwards at Ludford as the road is not sufficiently "urbanised" at this location and would need a degree of traffic calming measures to enable speeds to be significantly reduced.
- c) Shropshire Council are unable to provide a vehicle activated sign in the 30mph speed limit in Ludford as there is not a suitable location site for required pole and solar powered sign due t the wooded and closed nature of the site.

3. Chairman's Report:

The Chairman highlighted the following items in his annual report:

The proposed development of the new Ludlow Hospital

The Policies of the New Shropshire council which has seen the publication of the Core Strategy for Planning Development, revised affordable Housing Policy and currently the proposed Site Allocations and Development Management Policy

Highway Matters with the introduction of 30mph speed limit in Ludford and The Sheet still pursuing a reduction in the speed limit on Overton Road from Policeman's Corner to the current 30mph sign by Lower Barns Road Junction and a reduction in the 40mph speed limit at Rocks Green.

The Chairman thanked members of the Parish Council for their contribution during the year and also to the Clerk for his work.

4. Parish Council's Income and Expenditure 2009/2010:

The Clerk had produced a detailed statement of the Parish Council's expenditure and income which showed balances of £3,115.99 at the 31st March 2010.

5. To consider the Consultation Document issued by Shropshire Council Issues and Options Site Allocations and Management of Development (2006-2026)

The Parish Council had circulated an invitation to all households with details about the consultation and the Chairman remarked on the excellent turn out by members of the public to discuss this matter.

The Chairman welcomed Shropshire Councillor Martin Taylor Smith to the meeting The Chairman explained that the consultation document had identified potential site for development particularly housing although it should be stressed that no decision had been made on any site. In Ludford Parish Area land had been identified in the South /South East of Ludlow (Ludford), East (Foldgate Lane and The Sheet), North East (Rocks Green).

Potentially the Plan seek a growth of approximately 800-1000 houses during the period of the plan with currently 145 houses having been developed and current planning permission for a further 232.

Mrs I Liddle had researched and obtained details of potential Brownfield sites in Ludlow which could potentially provide for 250 houses.

Martin Taylor Smith explained the background to the policy which had developed from the Shropshire Councils Corporate Plan and West Midlands Regional Policies.

A Video had been explains n produced by Shropshire Council which can be viewed on CD or on the Shropshire Councils website which provides more background detail.

The Chairman explained that Ludford Parish Council could not support development in the South due to access over Ludford Bridge parts of land suggested were also in a flood plain and it would also destroy the scenic approach to Ludlow, Foldgate Lane because access was impossible and Rocks Green.

The Policy document had given no thought to the required infrastructure in relation to Transport, Schools and other essential services and lacked any detail about Housing needs.

The meeting was opened to the Public who ask various questions of the Parish Council and Shropshire Councillor Martin Taylor Smith.

It appeared that the meeting would prefer development to take place in the North and North east of Ludlow.

To conclude the Chairman informed the meeting that there would be a joint meeting with Ludlow Town council and encouraged all present to submit their views to Shropshire Council by the 25th June 2010
