003/14	NHS Defibrillator	<p>Rauf Ashraf from the Oxfordshire NHS Foundation Trust ambulance service briefly addressed the meeting regarding a pilot project in West Oxfordshire which is locating defibrillators in rural village locations. The NHS are now looking to expand provision to other areas of the county.</p> <p>The cost of a defibrillator would be £1,400 and would need to be locked in a secure box (approx. cost £750). It would need to be placed in an accessible location such as a phonebox or public house. The logistics of locating a defibrillator in the community were discussed and it was decided that it was unlikely to be a practical purchase at this stage.</p>	For info. Decision

006/14	Public Forum	<p>Clay Shoots: A brief discussion regarding the clay shoots at the Crazy Bear Hotel took place. It was confirmed that the issue will be fully debated at the public village meeting being held on Tuesday January 21st, 2014. The Clerk has invited all involved agencies including SODC, OCC, the local police, local councillors and representatives from the Crazy Bear hotel.</p> <p>Home to School Transport: MP reported that the consultation period has been extended for 2 weeks. Phil Cross (PC) reported as follows:-</p> <p>Budget setting: SODC is currently setting its 2014/15 budget.</p> <p>Merger of Office Space: The Vale of White Horse are to move the majority of their staff to the SODC offices at Crowmarsh Gifford as part of a cost cutting exercise. Oxfordshire County Council will be relocating to the Vale offices in Abingdon.</p> <p>Clay Shoots: PC confirmed that SODC officers have confirmed that the Crazy Bear have shooting rights for 28 days per year only. DF noted that there are some ongoing issues regarding how the management committee moves forwards and that plans for car parking are being progressed.	DF For info.
009/14	Fireworks Event, 2014	PS noted that that the bonfire event held on 5/11/13 was the most successful ever with over £4,000 being collected on the night. Unfortunately, however, the PC and fireworks committee have had to pay almost £2,000 between them in clear up costs as the Green was used as a 'dumping ground' for a lot of general rubbish, sofas and builders waste. Once the fireworks have been paid for it is unlikely that any profit will have been made and serious thought needs to be given to the sense of building a bonfire for the 2014 event.	PS For info.
010/14	Report from Oxfordshire County Council	<p>Cllr Lorraine Lindsay-Gale (LGG) forwarded a report as follows:-</p> <p><u>Budget Setting</u> OCC is preparing for its budget setting in February OCC. A further £61million has to be found over the next four years and there are no easy options - whatever is saved from one service will mean a cut in another. Whatever decisions are eventually taken, OCC will meet all statutory obligations, protect essential services and look after the most vulnerable elderly and young people in the county.</p> <p><u>Small Grants</u> SPC has received a grant from LLG's delegated budget for small schemes to replace a small section of footpath outside the Primary school (Cratlands Close). Thanks were expressed to LLG.</p> <p><u>Home to School Transport</u> LLG reported that she was aware that Stadhampton parents, governors and teachers were concerned over the long term impact that the proposed changes may have upon pupil numbers and therefore the viability of their schools.
