# CHIDEOCK PARISH COUNCIL

Minutes of the Parish Council Meeting held at the Village Hall, Chideock on Tuesday 31 October 2017 at 10 am.

The Parish Council meeting commenced at 10.00 am.

Present: Cllr Rob Murray, Cllr Peter Hunt, Cllr Laurie Elliot, Cllr Kate Geraghty and Cllr Vanessa

Glenn.

In attendance: The Clerk and 6 members of the public.

Mr Richard Benjamin, Village Hall Committee Chair, apologised that the Parish Council meeting was having to be held in the Committee Room due to works being carried out in the Hall and said that no charge would be made.

The Clerk welcomed Cllr Vanessa Glenn to the Parish Council.

#### 2046 Apologies.

Cllr Roger Carey and Cllr David Rogers sent their apologies, which were accepted. West Dorset Councillor Simon Christopher sent his apologies.

### 2047 Election of Chair for the meeting.

As both the Chair and Vice Chair were absent it was necessary to elect a Chair to conduct the meeting.

Cllr Geraghty proposed Cllr Hunt. This was seconded by Cllr Murray. Cllr Hunt, being willing, was elected unanimously.

#### 2048 **Grants of Dispensations.**

Cllr Glenn had requested, in writing prior to the meeting, a dispensation regarding her Defined Pecuniary Interest in Land or Property in the Parish, which would prevent her participating and voting on any Agenda item regarding Budget and Expenditure now or in future years until the next Parish Council Elections in May 2019.

The dispensation was **GRANTED** by the Clerk.

All other Councillors have been granted this dispensation at an earlier date.

#### 2050 Minutes.

a) RESOLVED to accept and sign, as a true record, the minutes of the Parish Council meeting of 24 September 2017.

Proposed by Cllr Elliot, seconded by Cllr Murray, carried unanimously by those who were at the meeting. Cllr Geraghty and Cllr Glenn abstained as they were not present.

#### 2052 **Democratic Period.**

Members of the public spoke on the following matters: -

With reference to the GATSO speed cameras: Who is responsible for the GATSO cameras?

The Clerk said that direct responsibility lies with Dorset RoadSafe.

What funds do our two cameras generate and where does this money go? The Clerk CC

- said that she did not know but would make enquiries.
- Surely, any money being considered for repairing the existing cameras (which seem to be not working more often than they are working) would be better spent towards the modern technology of average speed cameras (as suggested in the previous minutes (ref. 2037 item 21))
- In light of the high cost suggested for a bypass outside of the Parish boundary (HE meeting notes 4.f) will the Parish Council re-consider the proposal for one inside the Parish boundary, from Berne Lane to Morcombelake.
- What progress is being made with Sir Oliver Letwin MP regarding both a bypass outside of the parish boundary and introduction of a low emissions zone? The Clerk said that a meeting with Sir Oliver has been arranged on these matters.
- The minutes state that the PC's current priorities are LEZ and ASC, yet their implementation is not expected until 2020. Why three years (added to the years already spent discussing these two things).
- What is the route of the All-Weather Path mentioned in HE notes 4b) as being to the north of A35?
  - The Clerk explained the reasons why a northern route is being considered rather than the previous southern route.
- What are the 6 trends reference mentioned in the HE notes 3a)?
- When will the Community Severance Feasibility Study Report mentioned in HE notes 3 c) be complete?
- When will the report from the Gas-to-liquid (GTL) Fuel Emissions Testing be available. as mentioned in HE notes Appendix A, Study 9.
- What is going to be done to improve the junction of Bullen's Lane / Bridleway 20 at the junction with the A35? Neighbouring properties voluntarily clear as much as they can but more is needed. The lack of visibility for walkers and of walkers is dangerous. Cllr Geraghty explained that the Chideock Society is working with the Parish Council on this and funding is being sought from DCC Rights of Way and other sources to improve the junction and the small triangle of land known as St Jude's by hard landscaping and moving the wall adjacent to the A35 back to provide a pedestrian refuge and improve visibility. DCC Rights of Way will be clearing the area on 22 November 2017 and volunteers are required to help.
- Mr David Everidge said that he has received an update from Simon Williams regarding the formation of formal passing places on Sea Hill Lane, to be constructed on land which he owns. DCC have funding for detailed design.
- Has any consideration been given to providing charging points for electric cars?
- At the last Parish Council meeting it was informally suggested that a member of the Chideock Bypass Working Group could be on the Parish Council A35 Advisory Group. The Chideock Bypass Working Group said that the group wished to nominate Mr Tony Peacock as their representative on the Advisory Group.
  - This suggestion was welcomed by Cllr Hunt.
- The Chideock Bypass Working Group has queried with HE why a member of the group cannot attend the Quarterly meetings and reported that HE did not oppose their attendance.
  - The Clerk requested a copy of the correspondence.

Standing Orders were resumed.

#### 2053 Updates to the Follow-Up List.

AGREED that publication by WDDC of the 2016 Air Quality Report should be added to the Follow-Up List.

**Item 8 and 9 – X51 Bus. AGREED** to write to First Bus Wessex strongly protesting about the change to the X51 service, with buses terminating at Bridport from both directions, which can cause a lengthy wait for passengers wishing to travel beyond Bridport.

**Item 15 – A35 Resurfacing. AGREED** that the letter from David Groves a) sent to the Chideock Bypass Working Group and other interested residents, b) put on the Community website and c) reported in the December Chideock News. David Groves had informed the Clerk that he has no objection to this.

Item 15A - A35 meeting with Oliver Letwin MP on 17 November 2017. Cllr Carey, Cllr Elliot, Cllr Glenn, Cllr Murray and Cllr Rogers have confirmed they will attend. Cllr Hunt wishes to attend and will confirm his availability to the Clerk. Cllr Geraghty is unable to attend.

**Item 18 – Average Speed Cameras.** Cllr Glenn said that CPC needs to find out which body is responsible for providing the speed cameras and what is being done to secure funding. **AGREED** that this will be pursued by the A35 Advisory Group.
