

CHIDEOCK PARISH COUNCIL

Minutes of the Parish Council Meeting held at the Village Hall, Chideock on Tuesday 28 February 2017 at 10:00 am.

Prior to the Parish Council meeting Sandra Brown, Dorset & East Devon National Park Team, gave a brief presentation about the proposed Devon and Dorset National Park, followed by a question and answer session. 10 members of the public were present.

The Parish Council meeting commenced at **10.35 am**.

Present: Cllr Roger Carey (Chair), Cllr Peter Hunt, Cllr Rob Murray, Cllr Geraghty, Cllr Irena Champion, Cllr David Rogers.

In attendance: The Clerk and 5 members of the public.

1923 County and District Councillors' and Police Reports.

Cllr Simon spoke briefly of his support for a Dorset National Park; the need for affordable housing but only when it is financially viable for the developer; the importance of grant payments to young farmers (aged under 40) who are essential for the future of farming in Dorset.

1924 Apologies.

Cllr Laurie Elliot sent his apologies, which were accepted.
Dorset Cllr Daryl Turner sent his apologies.

1927 Minutes.

- a) **RESOLVED** to accept and sign, as a true record, the minutes of the Parish Council meeting of 31 January 2017 after the following amendment was made: -
- page 4, minute number 1918, final sentence – replace “met” with “meet”
Proposed by Cllr Rogers, seconded by Cllr Geraghty, carried unanimously.

1928 Motions Received with Notice.

Cllr Rogers proposed an amendment to the motion – *in italics*: -

“Chideock Parish Council notes *and strongly endorses* the opportunities a National Park could offer Dorset, welcomes the evaluations now under way, and will join with other Dorset and East Devon councils to invite Natural England to take its assessment to the next stage.”

The amendment was seconded by Cllr Geraghty and carried unanimously.

The revised motion was proposed by Cllr Carey, who had proposed the original motion, seconded by Cllr Champion, carried unanimously

Standing Orders were suspended for the following item.

1929 Democratic Period.

Members of the A35 Bypass Group gave a progress update. A version of the questionnaire (with map) is on the website, a version (without map) is in the March Chideock News and a printed version (with map) will be taken to every house in the Parish and direct contact made with every resident. All responses are required by the end of March, when they will be analysed.

The group thanked the Clerk for sending them the minutes from the latest quarterly meeting with Highways England and expressed disappointment that HE has not agreed to an A35 By-Pass group representative being present. The group is interested in the status of the National Route Strategy study. The Clerk suggested that the questions be sent to her so that she could ask for a response from HE now rather than waiting for the next quarterly meeting.

The owner of Japonica Cottage said that he reported an issue with a BT cover last summer and nothing has been done to rectify the problem. The Clerk asked for the correspondence to be sent to her so that she could follow it up. CC

The owner of Rose Cottage asked what can be done to improve the area where Bridleway 20 (Bullens Lane) meets the A35. The Clerk explained that the Chideock Society hopes to take this matter up in the longer term, and that Connect have said that they will clear it in the short term.

Standing Orders were resumed.

Items 20 to 22B – A35 Speed Cameras. Clerk to suggest that Dorset Road Safe and HE liaise on this matter. The problem in the past has been funding for Average Speed Cameras – has this been resolved? The Parish Council strongly favours Average Speed Cameras rather than replacement of the GATSO cameras with digital cameras. CC

“Condition 4 must be kept for the smaller of the 2 units.

For the other unit, Condition 4 could be relieved for as long as the Bed and Breakfast facility continues and should revert back when this use ceases.”

AGREED to seek advice from DAPTC regarding the request from the A35 By-Pass group for reimbursement of the cost of printing 350 copies of their questionnaire regarding a Chideock By-Pass as such a payment would have to be made under the power granted by Section 137 of the Local Government Act 1972. **CC**
