## Minutes of the meeting of the Planning Committee held on 05th May 2022 at Newfound Pavilion

# 1. Apologies

#### 3. Applications

The Chairman agreed to discuss application 22/00967/HSE first due to a member of the public attending having an interest in the application.

**22/00967/HSE** | Erection of a summer house in rear garden. | The Barn House Rectory Road Oakley Hampshire RG23 7ED

Members had no comments and no objections.

**22/01135/GPDE** | Erection of a single storey rear extension (permitted development notification) | 33 St Johns Piece Oakley Basingstoke Hampshire RG23 7JG Members had no comments and no objections.

**22/01012/HSE** | Erection of extension to side of property following demolition of existing carport | 8 Oakley Lane Oakley Hampshire RG23 7JZ

Members had no objections to this application but would like to confirm if a conservation officer needs to review the application as the property is in a conservation area.

**22/00986/FUL** | Erection of new dwelling and detached garage | Land East 4 Andover Road Oakley Hampshire RG23 7HB

Members agree with this application in principle and understand a previous application was granted. However the Members would like to ensure there is clarification with boundaries with neighbouring properties and there is safe access for traffic, in particular construction traffic. The Members would like to see the dimensions added to the garage drawings.
