1.	A resident has written to TVBC enquiring as to landowner's responsibility with respect boundary walls surrounding listed properties. He stated that the previous TVBC Heritage officer indicated that where properties were listed, boundary walls would also be so listed. Mention is made of the Winton House boundary, Five Bells Lane, and it is asked if the proposed planning application for this property include advice as to the treatment of these important feature walls boarding those listed buildings. 2.	HCC Highways officer was met on 17 th November. The HCC consultation responses regarding reducing the 30mph to 20mph speed limit are being analysed. A report is likely to be issued in April 2023. NWPC have requested more road signs and/or other measures along the routes that children travel to school. This includes the areas that secondary school children walk to the 3 Test Valley School Bus stops. HCC will be requesting a copy of the Primary school travel plan. Road markings to promote traffic calming along the A343 crossroads, and along Farley and Heathman Street will be considered by HCC and rough estimates for costings will be produced early in 2023. 3.	Metal detectors, the council's insurers will not insure anyone metal detecting at the playing fields and require that Council permits can only be given to persons that have applied to the council, confirm they will adhere to the terms and conditions set out by council, and provide the council with their own public liability insurance and risk assessment. 6.	CIL Grant Bid. It is disappointing that the result of the PC Grant application for £101k are still not known as we had been told that a decision would be publicised in December. TVBC have advised: "The reason the report is going to 18th January Cabinet is simply the time needed to assess the bids and then provide informed recommendations to Members. The timeline has been; 1st April – 30th June: Submission of bids 1st July – 30th August: Assessment period September: Assessors meet to make recommendations October onwards is where the report is written and any remaining issues with bids are ironed out. All bids are assessed together and then taken to the same Cabinet meeting. I can say that no follow up was needed with your submission but work with other bidders may put any potential Cabinet date back in a given year. That has been the case this year.	No	None
