311. REPORTS FROM BOROUGH & COUNTY COUNCILLORS

Borough Cllr David Cooper said there had been little TMBC Business since the last PC Meeting and **REPORTED** on the following items:

PLANNING

The reserved matters for the Orchard Mill development were approved on 23rd December. As was agreed when the original application was debated at the Area 3 Planning Committee, the reserved matters was delegated to Planning Officers. St Modwen Homes has restarted work on the site today after the Christmas break. The site manager informed me that they have a couple more weeks work to do on the infrastructure before starting to build the homes. You will have noticed that there is now signage advertising the development and St Modwen Homes has already had a number of enquiries and people registering an interest.

Some residents have expressed concern about footpath MR100. The wire fencing along the footpath will be maintained to prevent unauthorised access to the building site for as long as necessary. This has been replaced in areas where the chain link and post and rail fencing was either in poor condition or not of a high enough security standard. A crossing will be installed at some point to allow access for site traffic to the area on the west side of the path and the gates will be manned when vehicles need to cross. Any long-term closure of the PROW will require approval from KCC.

The site manager is happy to give parish and borough councillors a tour of the site and suggests this be done in a few months when some houses have been built and the site is not quite so muddy.

The next Area 3 Planning Committee is scheduled for 2nd February. The Bushey Wood application was scheduled to be heard at this meeting but we are advised that this has been postponed to a later date.

PUBLIC CONSULTATIONS

TMBC's public consultation on Public Space Protection Orders closes on 15th January.

TMBC's consultation on its Draft Corporate Strategy for 2023 to 2025 closes on 10th February. There will also be an MS Teams meeting with the Leader of the Council and Council Officers at which anyone can join and put questions. This will be at 6.30pm on 17th January. See the TMBC website for details of how to log in.

Applications for TMBC's shopfront and vacant unity improvement scheme went live today and applications close on 8th March. TMBC has sent letters to eligible premises but owners of any shop, vacant or occupied, who feel that they may be eligible are encouraged to check the website.

Details of all these consultations are on the TMBC website.

COST OF LIVING

The TMBC website gives advice on ways the public can get help and support in coping with the current cost of living crisis. Whether it be advice on finding warm spaces, reducing energy bills, food banks and paying the bills the website gives advice and provides links to organisations that can help.

WASTE COLLECTION

The snow in December and Christmas and New Year Holidays delayed some of the bin collections but these should now have returned to the normal schedule. Residents are encouraged to check the TMBC website where a link updates to the waste collection service is on the front page. Collections over the holidays were delayed by one day and this was

advertised by TMBC well in advance on the website. However it was noticed that many residents still put their bins out on the Wednesday.

Cllr Cooper made the council aware of two other issues, details are contained in Confidential Memorandum Ref. 440.
