Proposal	Erection of a detached dwelling with associated parking and amenity space.
Draft Bramley Parish Council Response	Objection: There is no difference between the proposed dwelling in this application and the previous application (WA/2021/02729) which was refused on appeal. The reasons for refusal still stand:  1. The proposed development, by reason of its siting, plot size and design would be harmful to the character and amenity of the area. The proposal would constitute cramped and contrived development and would fail to respect the character of the surrounding area. The proposal therefore conflicts with Policy TD1 of the Local Plan 2018 (Part 1) and retained Policies D1, D4 and RD1 of the Local Plan 2002.  2. The proposed dwelling, by reason of its siting and design, would have a harmfully overbearing impact on the neighbouring dwelling, Tyrolia. The proposal therefore conflicts with Policy TD1 of the Local Plan 2018 (Part 1) and retained Policies D1 and D4 of the Local Plan 2002.  3. The amenity area of the proposed dwelling would be harmfully overlooked by the neighbouring dwelling, Tyrolia, and would therefore fail to provide an adequate standard of accommodation to future occupiers. The proposal therefore conflicts with Policy TD1 of the Local Plan 2018 (Part 1) and retained Policies D1 and D4 of the Local Plan 2002.  The applicant has engaged a team of consultants to attempt to show that there would be no environmental impacts from the proposed building but omits to mention that the plot is now a wasteland because he himself destroyed the vegetation thereon that housed countless wildlife.

### Library report




We have seen a pleasing increase in new volunteer enquiries. A couple have recently started training, and we have another in the pipeline.

#### Incident Report - Cannabis Farm Bust in Farnham (7 November)

This morning at 8:40 am, a successful S23 Misuse of Drugs Act warrant execution took place at a warehouse on Crondall Lane, Farnham. Two individuals were arrested on suspicion of cultivating cannabis, and a substantial cannabis farm spanning two levels was seized.

#### **Arrested Individuals:**

- A 20-year-old man arrested on suspicion of cultivation of cannabis.
- A 34-year-old man was arrested on suspicion of cultivation of cannabis.

Both individuals are currently in police custody.

Sergeant Michael Knight emphasised the ongoing nature of the investigation, with officers continuing their work at the scene. The success of this operation underscores the importance of public cooperation, as these warrants stem from information provided by vigilant community members. Sergeant Knight encourages the public to report any suspicious behaviour directly to the police through messaging channels to facilitate a comprehensive understanding of potential criminal activities in the area.
