081/23 PLANNING APPLICATIONS WITHIN MARDEN PARISH

FULL APPLICATION

23/503395/FULL - Blue House Farm, Battle Lane, Marden

Erection of a two-storey side extension and changes to fenestration. Conversion of outbuilding to annex ancillary to the main dwelling. Erection of a detached single storey gym building. Erection of a part retrospective new single storey garage building with office. Cllrs raised no objection but wished it to be conditioned that the annex is ancillary to the main dwelling.

23/503509/FULL - 11 Merchant Place, Marden

Demolition of existing conservatory and erection of a two-storey rear extension including changes to fenestration.

Cllrs, in principle, have no objection but they do have a concern about the overbearing impact of the rear extension on the neighbouring properties and note that the side elevation window could potentially overlook the neighbouring properties as well.

Cllrs also note the use of Cedral cladding to the first floor extension – this appears not in keeping with the local vernacular.
