The Chairman will report that the following planning applications have been considered by the Planning Sub-Committee with the following submitted decisions.

14/02903/FUL Erection of 4 No. terraced dwellings (to include 1 No. affordable) and formation of new vehicular access at Land off Benthall Lane, Benthall.

**Objection** – Land is in the Broseley Conservation Area and very close to 3 Grade Listed Buildings.

The development is for a terrace of houses which is not in keeping with the style of buildings surrounding it.

The development would ruin the orchard and other trees on which the garden was based.

The new vehicle access would also remove a number of oaks and increase the flow of traffic near to an already busy junction.

The development shows a very crowded site with parking and waste storage which would give a detrimental visual impact on those passing and neighbouring properties.

Concern about the wildlife.

Would the site need archeological survey?

14/02972/FUL Erection of single storey extension following demolition of existing at The Bayliffs House, Spout Lane, Benthall.

**Objection** – The age, prominence and history of this Building, which is listed and in a conservation area, means that we have some concerns about the current proposals. Although we wouldn't disagree with the desire to replace the existing extension, the consensus of opinion is that the proposed development would be unsympathetic to the existing building. The proposed glazed area on the south elevation of the extension is out of keeping with the historical features already visible and we therefore object to this application.

We would also like some clarification on the material to be used

for the proposed resurfacing of the access road.
