DRAFT MINUTES OF THE MEETING OF BORDEN GATE PARISH COUNCIL

MEETING 55 HELD ON 27.03.2024 AT HUNTSHAM VILLAGE HALL AT 7.30PM

Public question time: A member of the public spoke about the state of the road known as Park Lane in Huntsham which runs from the war memorial up towards Bampton Down, pointing out the mud on the road near the church, explaining it had been carried there by water because the ditches are not maintained. The Chair responded with an expression of gratitude that the matter had been brought to the attention of the Parish Council.

- 2. **Declarations of interest** E Northam Item 6a declared an interest.
- 3. **Minutes** of the meeting held 31/01/2024 were unanimously approved and were signed as a true and correct record by the Chairman H Cocoran.
- 4. Roads and Traffic Issues - Councillors' had raised a number of issues with roads in and around the three parishes which had been submitted to the Neighbourhood Highways Officer for a response. Devon County Councillor Ray Radford was in attendance to help address these concerns. Cllr Radford informed the meeting that Devon has over 8,000 miles of road and a limited budget. He explained that 80% of the traffic travels on 20% of the roads and money tends to get directed to these areas rather than the lowtraffic rural roads. However, Councillors felt that the rural network was being neglected at the expense of the towns. There was a discussion about the water on the roads and who has responsibility, which in many cases is the landowner. Further discussions were held on the effectiveness of pothole repairs, particularly where one is filled in while a neighbouring one is left undealt with. This is due to the contractor being paid per reported pothole. Councillors thought a better system could be devised, which would also save money by avoiding return trips. Cllr Radford explained that £9.4 million allocated for potholes and repairs has already been spent this year. Councillors were of the view that repairs, particularly those done by the Dragon Repair machine were not of good quality, and better repairs were required. Cllr Radford advised that members could write to the Chief Executive of Devon County Council to express their views. He also advised that the Parish Council write to the Chief Executive and requested to be copied into any correspondence to help achieve a response.

Matters Outstanding

- a. Chimney Down & S106 Application MDDC Cllrs Lock & Westcott had now written to confirm their support for the application. Clerk collating quotes for installation of proposed plan and continues communication with those in the area. It is unlikely that the project will be delivered totally within the money available through S106 funding. Devon County Councillor Ray Raford has offered £250 towards Chimney Down from the Locality Fund available in the upcoming new financial year.
- b. Parish Paths Partnership (PROW) Clerk continues to collate walks for Mid Devon's walking festival.
- c. Huntsham Bench Clerk awaiting quotes to install bench. Decision will be made at a future meeting.

- 8. **Parish Council Risk Assessment** The Clerk had prepared and circulated a financial risk assessment. Councillors praised the document and M Williams proposed and P Osman seconded, and it was unanimously approved with no changes made.
- 9. **Police reports** email alerts posted on Facebook. The current police team beat poster had been circulated and will be placed on the noticeboards.
- 10. **District and County Councillors' Reports** DCC Cllr Ray Radford provided a report prior to the meeting which had been circulated. Cllr Radford had been asked a question on the location of the proposed landfill site near Halberton which is a decision for Devon County before he left due to the need to attend another meeting. MDDC Cllrs Lock and Westcott had provided reports prior to the meeting which had been circulated and placed on the website.
- 11. **Clerk's Report including Correspondence** Mid Devon Mobility Transport had sent an acknowledgement and thank you for the donation received. Notices of election for the Police and Crime Commissioner had been posted on the website and noticeboards.
- 12. **Councillors' reports and items for future agenda** Cllr Cocoran informed Councillors that Hockworthy Village Hall had been in receipt of a grant towards the purchase of a defibrillator which has now been installed. A request to organise defibrillator training was made. The Clerk to organise. A Hoskins informed the meeting that Social Services are booking holiday accommodation at short notice without providing

details of who is staying. This resulted in the need to involve other public services (police). Cllr Delafield Cook reported that there is to be a tabletop sale on the 4th May at the Old Vicarage starting at 9am. Cllr H Bainbridge had been chosen from the draw by the Devon Association of Local Councils to attend the Buckingham Palace Garden Party in May. The Road Warden Scheme will be an agenda item at the next meeting.
