Cllr. Barkham:

- o Cannot see an objection to the plan.

Cllr. Barton:

- o Also, cannot see an objection to the plan, but don't like the roof too intrusive.

Cllr. Burrows:

- o Roof would be better to be tiled in keeping with existing. Could be argued that there will be an effect on light into neighbouring property. If this is in the conservation area then don't support, but not sure there is a strong objection.

Cllr Jane Sullivan:

- o It would be too crowded.

Cllr Patricia Maxwell-Arnot:

- o It is overdevelopment. A disproportionate amount of density on a small site.

Cllr. Cullimore:

- o Agrees with the opposing comments.

**It was proposed by Cllr Maxwell-Arnot to Object to the application as six parking spaces for a three-bedroom house is excessive. The site is overdeveloped. The building would be too high, risking blocking light to one of the neighbours and is against the Village Design Statement policies 3S2, 3S3, 3S5, 3S11. Seconded by Cllr Burrows and resolved unanimously.**
