Highways Reporting a Personal Experience:

A parish recently reported that there were dangerous tree branches leaning on power lines immediately adjacent to the highway and asked me to report it. I went the extra mile and created a map of the exact spot and included several photos, then pressed SEND to our own Highways department. Shortly afterward a response was received asking me to report it to Power Networks, as it would be their responsibility.

This I did, and after some length discovered that Power Networks did not have any overhead cables in that area, therefore the cables would be an issue for BT and /or Openreach, so I should report to them.

After several attempts and failing to find a suitable email address for BT/Openreach to which I could make a report, I was reduced to 'chatting' to a helpful, but irritating, robot, probably located somewhere off shore, and which was an utter waste of time.



So I went further up the chain and sought more advice on how any individual could report potential problems with overhead lines, or trees, which were other than an "Immediate Danger to Life". Seems no one is interested in prevention.

Eventually however, I did discover the link below, which anyone is encouraged to use to report dangerous, or potentially dangerous, situations covering BT cables, poles, cabinets or manholes (or call: 0800 023 2023):

IF you are able to discriminate between cables belonging to Power Network and BT infrastructure, then the contact for Power Networks would be: 0800 316 3105 or 0800 029 4285 or 105.

At the time of writing no email address to report this type if incident was available for any of these providers. For anything you may believe to be an 'immediate danger', you may use the 999 emergency system, and all will require a Post Code if possible.

East Sussex residents asked to give views on Local Transport Plan

A public consultation asking local residents and businesses as well as the wider community what they think of the transport proposals for the county will run until 25 February. The plan looks ahead until 2050 and sets out how East Sussex County Council will plan and provide transport. The plan's objectives include decarbonising transport, creating safer and healthier communities, delivering better access to jobs and services, and improving transport reliability.

Reduced single bus fare scheme continues in Sussex

Bus passengers will continue to be able to get around Sussex for as little as £2 until next summer. Operator Stagecoach announced that they would be extending their £2 single bus fare scheme until June 2024 following its successful rollout earlier this year. The scheme will continue to be available on Stagecoach buses such as the 700 route operating in Sussex and nationwide.

East Sussex County Council, Hastings Borough Council and the Hastings Garden Town Team are working on plans which include greener connections for walking and cycling throughout the town, as well as improvements to public spaces. The project is supported by Transition Town Hastings and aims to complement the heritage of Hastings whilst creating spaces of public realm to promote wellbeing.
