#### Decisions from Daventry District Council:-DA/2016/1011

Land off Oxendon Road, Arthingworth,

Construction of 2.5m wide hardcore track incorporating entrance gates

Permission has been granted with the following conditions:-

1) Development begun within 3 years

2) Development in strict accordance with the submitted plans

3) The approved landscape scheme shall be implemented prior to the development. If within a period of five years from the date of the planting of any tree or shrub, they, or any planted in replacement for them, are removed, uprooted or destroyed or die another tree or shrub of the same species and size as that originally planted shall be planted at the same place. 4) The proposed frontage section of gate and wall shall have been constructed and completed within a period of 3 months following the completion of the access and track element.

# Other Planning Matters:-

Update from DDC regarding the wall and track on Kelmarsh Road (as given to the Parish Meeting):-

"This has been ongoing, my last visit was the 24<sup>th</sup> of March 2017 (where the wall was under construction and I spoke with the builders) and my senior officer was in the area Wednesday of this week.

Works still thus far appear to be permitted development, plans shown of the wall during its construction place it under 2 metres in height.

However post review today, I was directed by my senior officer to email the agent again to advise we still have concerns as to if the recent excavations may require planning permission, and that a new access may eventually be formalised onto Kelmarsh Road which would require permission.

I will update should there be further significant developments."

### Village Maintenance:-

- 1) Kelmarsh Road, outside 1 Sunnybank blocked drain. No action call closed 16/9. The clerk to ask why no action is to be taken. 848371 status changed to 'under investigation'. Telephone reply from David Coleman more urgent repairs are necessary where houses are being flooded.
- 2) Harrington Road by Rabbithill Spinney deep hole where the road has dropped away. 840752 site visited, defects do not currently meet ncc intervention levels will continue to monitor through highways safety inspections. COMPLETE
- 3) Pothole Braybrooke Road towards the last cattle grid going towards Braybrooke. 848372 work will be undertaken within 4 months. COMPLETE
- 4) Potholes Kelmarsh Rd within the village between the village hall and the Bulls Head. 853271 - site visited, defects do not currently meet ncc intervention levels will continue to monitor through highways safety inspections. The clerk to report again as the road is becoming dangerous. Potholes are now becoming extremely dangerous causing a substantial trip hazard and also causing cars to swerve on a road already narrow. Many complaints were received at the recently held Parish Meeting - 867515
- 5) Potholes- outside 20 Oxendon Road 864645 site visited, defects do not currently meet ncc intervention levels, will continue to monitor through highways safety inspections.
- 6) Between Nos. 2 & 3 Kelmarsh Road the resurfaced footpath a pothole has been filled inappropriately and the surface is breaking up.
- 7) Drain opposite 5 Kelmarsh Road gully needs cleaning. The clerk to check when the next inspection is due.
- 8) The bench on Harrington junction to be checked. A Cllr to check
- 9) Light on corner of Hall Close still not working first reported 6<sup>th</sup> February 2017. The clerk to chase.

#### Consultations:-

1) Northamptonshire County Council – 30 Hours Free Childcare - Parental Demand Survey – Cllr. Nikel – No reply made.

#### Defibrillator:-

Cllr. Blake updated the meeting as follows:-

- 1) Various sources had been investigated and East Midlands Ambulance Service appeared to be the most cost effective.
- 2) Cost £999 plus VAT including a cabinet.
- 3) The village hall committee had agreed in principle that it could be placed on the wall.
- 4) There is a possible grant of £500 available.
- 5) There is a possible charge of £200 for fitting.
- 6) Ongoing costs would be about £75 every two years for a battery.
- 7) Donations are to be requested.

It was proposed and seconded and unanimously agreed that Cllr. Blake proceed.

Cllr. Blake to provide something for the website.

### Speeding in the Village:-

Complaints were made at the recently held Parish Meeting. It has been established (from NCC) that:-

- 1) The Parish Council has no authority to place any signs on highway land.
- 2) Signs can be placed on privately owned land.
- 3) NCC will visit the village in the next few weeks to place signs wherever possible but these are used on a rotational basis therefore they will be removed after a few weeks but will be placed again as necessary.

The clerk to contact Daffodils Outdoor Nursery to request parents respect the speed limit.

Cllr. Kennedy to write in the newsletter requesting residents drive carefully through the village.
