

## Risk assessment for volunteer litter clearance (Group Events)

<b>HAZARD</b> (A source of potential danger)	<b>PRECAUTIONS</b> To remove hazard, reduce risk	<b>MEASURES TO REDUCE EFFECT IN THE EVENT OF AN ACCIDENT</b>	<b>MANAGEMENT ACTIVITY</b>	<b>PLEASE INITIAL TO INDICATE UNDERSTANDING</b>
<b>Traffic</b>	<ul style="list-style-type: none"> <li>• Prearrange roads/areas to be picked – ensuring below 30mph, highlighting potential hazards e.g. poor visibility, bends etc.</li> <li>• Use of reasonable safety measures.</li> </ul>	Be aware of oncoming traffic and other hazards. Ensure use of Personal Protective Equipment. Do not use mobile phones or headphones whilst on a highway. Be aware that road users may travel in excess of the limit.	One volunteer to act as 'eyes and ears' for traffic movements on behalf of the rest of the group.	
<b>Lifting heavy objects</b>	<ul style="list-style-type: none"> <li>• Do not move or lift objects unless necessary</li> <li>• Use mechanical aids, or handle with a number of people. Break up the load into smaller parcels.</li> <li>• Use good lifting technique.</li> </ul>	Stop immediately if suffering any pain or discomfort. Seek medical attention if ill effects persist.	If volunteers find large/heavy objects, make a note and report to the local council for removal after the event.	
<b>Chemicals</b>	<ul style="list-style-type: none"> <li>• Do not approach or remove containers which contain/contained chemicals</li> </ul>	Seek medical attention if exposed to pesticides, insecticides or other chemicals – record any label details.	Contact the Environment Agency 0800 80 70 60.	
<b>Steep slopes</b>	<ul style="list-style-type: none"> <li>• Avoid picking on or close to the edge of steep slopes etc</li> <li>• Take weather conditions and possible weather changes into account</li> </ul>	Seek medical treatment in the event of injury.	Instruct volunteers to stay away from these areas.	
<b>Electric fences</b>	<ul style="list-style-type: none"> <li>• Always assume electric fences are live</li> <li>• Avoid contact</li> </ul>		Warn volunteers not to touch fences.	
<b>Ground conditions</b>	<ul style="list-style-type: none"> <li>• Wear strong boots with ankle support, especially on uneven ground.</li> </ul>	Seek medical attention for any serious cuts, bruises or strains	Instruct volunteers to wear suitable footwear.

	<ul style="list-style-type: none"> <li>Avoid dangerous areas and choose the safest possible route over difficult ground.</li> </ul>			
<b>Hedges Fences Walls Ditches</b>	<ul style="list-style-type: none"> <li>Take care climbing stiles particularly in wet weather</li> <li>Avoid climbing walls, ditches and fences</li> </ul>		Stay within the registered location.	
<b>Vehicles, bicycles, plant and machinery</b>	<ul style="list-style-type: none"> <li>Avoid close proximity if possible.</li> <li>Stay off the highway.</li> <li>Be alert to the potential presence of agricultural machinery.</li> <li>Wear high visibility clothing if necessary.</li> <li>Do not work on the roadside if the speed limit is 30mph or over.</li> </ul>	Seek medical attention in the event of injury.	Be aware of the vehicles around you during the litter pick. Keep a look out.	
<b>People &amp; lone working</b>	<ul style="list-style-type: none"> <li>Beware of aggressive and difficult people.</li> <li>Withdraw rather than face conflict.</li> <li>Do not work out of sight of others in the group.</li> <li>No school age children to be working on the highway</li> <li>School age children working <b>off highway</b> to be fully supervised at <b>all</b> times.</li> </ul>	Leader to have mobile phone. Medical attention following any assault.	Keep together and stay off private property.

<b>Refuse, litter</b>	<ul style="list-style-type: none"> <li>• Pick up only general litter.</li> <li>• Wear gloves and use a litter picker wherever practicable and available.</li> <li>• Volunteers should not over fill the collection bags.</li> <li>• Volunteers should be briefed to wash hands before eating/drinking/smoking.</li> <li>• Volunteers should take care when collecting sharp or pointed objects e.g. glass or metal.</li> </ul>	Seek medical attention for any cuts. Keep anti-tetanus injections up to date.	Volunteers must wear the safety clothing provided.	
<b>Hypodermic syringes</b>  <b>/ Drug paraphernalia</b>	<ul style="list-style-type: none"> <li>• Volunteers must not collect needles or drug paraphernalia. If found, the location should be noted and reported to Maidstone Borough Council for collection.</li> </ul>	If a needle stick injury is received then volunteers are to seek immediate medical treatment. Wound should be encouraged to bleed.	Instruct volunteers not to collect any needles or medical waste.	
<b>Tools &amp; equipment</b>	<ul style="list-style-type: none"> <li>• Team to be shown how to use equipment if appropriate.</li> <li>• Allow sufficient working area for the correct and safe use of the tool.</li> <li>• Use appropriate protection.</li> </ul>	First aid training. Have first aid kit available. Obtain medical attention in the event of injury.	Volunteers must use the equipment provided and as instructed.	
<b>Personal Protection Equipment</b>	<ul style="list-style-type: none"> <li>• All attendees to wear hi-visibility tops and gloves</li> </ul>		Volunteers must wear the safety clothing provided.	
<b>Trees and shrubs</b>	<ul style="list-style-type: none"> <li>• Be alert to the risks and keep a sharp look out for hazards.</li> </ul>	Obtain medical attention in the event of injury.	Be aware of low hanging branches and exposed tree/ shrub roots.

<b>Weather</b>	<ul style="list-style-type: none"> <li>Adjust work programmes to avoid extremes.</li> <li>Cease work in inappropriate conditions.</li> <li>Avoid over exertion in hot and cold extremes.</li> <li>Dress for conditions &amp; carry additional clothing</li> </ul>	Seek shelter.	In the event of extreme weather conditions, the litter pick should be postponed / suspended.	
<b>Individual capability</b>	<ul style="list-style-type: none"> <li>Check that individuals understand and are able to carry out voluntary work on site</li> </ul>		All volunteers to have sight of risk assessment. All volunteers to be given guidance sheets.
