# 1 WELCOME AND APOLOGIES

Thanks to Chairman for hosting the meeting. Apologies PC Andy Reid.

#### 4 HIGHWAYS & MAINTENANCE

### 4.1 Parish Council / HCC meeting of 15th December

<u>Attended</u> for HCC, Highways Engineers, Hants Flood and Water Management; for Parish Council, Alan Tyler, Simon Barker, Susan Turner.

Report from meeting included in January *Newsletter*. Chairman's notes of the meeting at **APPENDIX I.** 

TO CONFIRM 1. The pond silt traps are included within HCC's three x per year cleaning schedule.

- 2 Documents forwarded to Highways Engineer as agreed:
  - Chairman's notes of the meeting
  - Pond water testing report and quote for waste disposal.
  - Waterman hydrology report (2019 planning application for Southlea Meadow).

## 4.2 Gully map and cleaning schedule & grip maps – see APPENDIX II

Screenshots supplied of Highways' Assets map on Arc GIS showing gullies, and their cleaning rotas. (Reproduced in January *Newsletter*.)

Red dots are gullies on the max three x a year schedule. This is all of Farleigh Road and Farleigh Hill, three at the bottom of Church Lane (which are the silt traps and gully leading to) and two (the only two) gullies on Woods Lane.

(Plus two pieces of pipework (red lines) by the school and a pipe going across the road in the cluster of gullies on the southern boundary of Manor Farm.)

<u>Green</u> dots are gullies cleaned on the once a year schedule. These are two gullies on Hackwood Lane, one just above the Village Hall, and one on the inside corner at the junction with Northgate Lane.

<u>Grey</u> dots are gullies on the once every three years schedule (which is the default frequency unless further measures shown to be justified). This is Church Lane and Hoopers Mead.

## 4.3 Grips and soakaways.

HCC has a county-wide grip clearing programme running until the end of the financial year. They presently have no grips mapped for Cliddesden.

Highways engineer will put forward the Cliddesden request for additions to the programme (though most of these are in Farleigh).

**ACTION** 

Clerk to complete mapping of grips and soaksways – existing and requested additional – and forward to Highways Engineer. **APPENDIX III** 

<u>Existing</u> = 21 grips / soakaways on east side of Farleigh Hill, only two of these part functioning. The majority are between Otters Nursery and the top of the hill (the majority outside the Parish). Five grips / soakaways on west side Farleigh Hill all near the top part of the hill – all in Farleigh Parish, all need clearing.

<u>Existing</u> = Grip into 'new' security ditch at Hackwood Lane, Northgate Lane junction.

ALL ABOVE 'existing' (security ditch then a soakaway) cleared with digger by Cliddesden Parish Lengthsman Summer 2017 when the road was closed for verging. Mark Gifford noted that the road edges are eroded again, so channeling the water outside the path of the gullies.

<u>Proposed</u> Additional grips into this ditch at Hackwood Lane / Northgate Lane junction, new grips on Hackwood Lane from Northgate Lane to the Village Hall. New soakaway in wide verge opposite and above Village Hall entrance, see **APPENDIX III**.

#### 4.4 Pond and outflow

Letter drafted to Cllr McNair-Scott requesting that she actively pursue with HCC the Parish Council's request (submitted via Highways) to clear the pond. The request has been forwarded to Operation Resilience but to date no schedule or funding committment.

The outflow is not a Highways issue but, HCC being the local lead flood authority, it comes within the remit of Hants Flood and Water Management (FWM).

- Letter to be sent (Hants FWM) to property owners with riparian responsibility for the pond overflow watercourse, explaining their responsibilities.
- Hants FWM will consider surveying the watercourse to understand where it runs and how it might be improved.

#### 4.5 | Pond bench

Letter received from resident requesting the pond bench be moved. Following discussion, the Parish Council agreed unanimously that:

- 1. The current location is the most favourable, being largely in the sun and away from trees. It is in the best position for people sitting, and for the bench itself. If positioned in the alternative site under trees, it would need regular cleaning and be slow to dry out.
- 2. The bench has been in this location for many years.
- 3. It was noted that there used to be a second bench. Having another bench may be worth considering to better enable distancing and alleviate any overcrowding.
- 4. The green space around the pond is the central communal area of the Village and is for the benefit of all villagers and visitors. Should there be any antisocial behaviour this would of course be addressed by all means and by enforcement if necessary with the support of PC Reid, but any such instance should not prevent residents' opportunity to make use of the bench in its present location.

### 4.6 Lengthsman tasks

Scedule for visit of 16th December

- 1. Bus shelter Clear of vegetation and leaves, including from roof, gutter and downpipe and surrounds. Clear back vegetation from bus stop sign.
- 2. Strim around pond. Hedge cut around footpath and behind 'danger sign'.
- 3. Clear silt and debris from gullies, road edges surrounding pond and car park.
- 4. Clear grips into Southlea Meadow along length of Farleigh Road from bus stop layby to the field track.

No benefit in these grips being cleared by HCC, no flooding problem in this part of Farleigh Road. An annual check from the Lengthsman is sufficient.

Next Lengthsman visit 9th March

Bus shelter again. Clean, and remove all vegetation climbing on / overhanging. <u>Pending dry weather jobs</u> – Signpost by pond still needs painting (should be black and white) Other metal signs can be painted (plus legs straightened).

# **5.1** Road-side parking at Millars

PC Reid initially advised that: 'It is forcing vehicles to come around a blind bend on the wrong side of the road potentially causing a head on accident, and if there is, and they are shown to have caused it, they may well be liable. There is an obstruction offence also... Road Traffic Act 1988 c. 52 Part I Section 22: 'Leaving vehicles in dangerous positions' states: 'If a person in charge of a vehicle causes or permits the vehicle or a trailer drawn by it to remain at rest on a road in such a position or in such condition or in such circumstances as to involve a danger of injury to other persons using the road, he is quilty of an offence.'

<u>PC Reid visited on 15th December</u> and spoke to residents. It is the residents' cars being parked on the road, while the parking spaces are fenced off as part of the building site. Since PC Reid's visit it seems that parts of the site have been cleared so that some cars can be moved off the road.

Simon Barker has discussed with HCC who have indicated they will repair the road edges once building work has finished.

TO RECORD The Parish Council has sought all means to enforce against the on-road parking and associated roadside damage and danger to road uses. It seems there are no measures available, within the remit of the Police, HCC, or the Parish Council, to further improve the situation until the building work is completed.

#### **5.2 SID** and data recorders

Request published in the December *Newsletter* for volunteers to take on the SID data management; ie to download the software in order to receive the data and produce reports and summaries. The software, Houston Radar StatsAnalyzer, can be download free of charge from the website (Microsoft operating system needed).

THANKS to Andy Fewster who has volunteered to trial this. He has a copy of the software plus instruction book.

### **5.3** Woods Lane and signage

As agreed with Hants Safer Roads, new traffic warning signs with yellow backing boards have been installed in Woods Lane (c16 December). Councillors agreed that the yellow backing makes the sign stand out and much more noticable. Unfortunately they were installed lower on the post than previous signs and so blocking sight lines from driveways.

THANKS to Simon Barker for raising the signs sufficiently to restore visibility – and to residents for reporting the problem.

NOTED that the second phase of the works is to paint solid white lines to help steer drivers' eyes into the bend, plus a painted hatch section before the bad corner.

An additional possible and more costly measure (not yet scheduled) would be a buildout at top of the hill, forcing drivers to slow to navigate around it, and to give way to any traffic coming up the hill. This would help prevent drivers gathering speed by default when beginning the descent into the Village.

# 5.4 Village Gateways

**AGREED** 

Parish Council proposal

'To install Gateway features at Cliddesden's three main entrance points (as used by through traffic) – on Farleigh Road (N), Woods Lane, and Farleigh Road (S). The Gateways draw attention to place, impression of arrival – to impress upon drivers the experience of entering a Village and the need for care.

NOTED

- 1. HCC Policy requires these to be achieved via the 'Community-funded initiative'.
- 2. Application form drafted and circulated prior to submission.
- 3. 'Hants Safer Roads' team are fully committed with work for this financial year so any design work will be scheduled for the next.

**6 PLANNING** – See **APPENDIX IV** for current applications relating to the parish.

### **6.1** Recent applications

<u>20/03197/PIP</u> (Pending, Validated 19 Nov 2020) Permission in Principle for erection of 2 no. dwellings. Land Adjacent to 14 Hackwood Lane, Cliddesden. *Parish Council response agreed and submitted. In summary that this site is in the Open Countryside, contributing to broad landscape views and wildlife corridors. Developing the site would detract from the rural sense of place of this part of Hackwood Lane and be detrimental to neighbour amenity.* 

#### 6.2 Enforcement

<u>Millars</u> – Enquiry regarding permission and building of new cesspit, confirmed that this is in compliance with Building Regulation process with an Inspector assigned.

#### 14 Hackwood Lane

- 1. Removal of native hedging referred to Biodiversity, follow-up to previous correspondence. Planning Enforcement can deal with hedging relating to planning conditions. No planning consent needed to remove hedgerow bordering garden.
- 2. Change of use of adjoining agricultural land. Enforcement responded to double check exact location the photos related to. Case officer for the planning application for two new houses has been advised.
- 3. Driveway hardstanding, runoff contributing to flooding. No means to enforce four years after installation, no means to impose conditions post planning consent.
- 4. Apparent over-sized loft conversion and dormer window. Acknowledged.

#### Station Manor

Commercial units continue at the site which accommodate three companies generating daily traffic

ACTION Clerk to refer again to Enforcement.

# **6.3** Pensdell Farm meeting

A site meeting of 4th November attended by the Chairman and Alison Mosson at the request of John Jervoise for Herriard Estate. The Parish Council will listen to all proposals – in this case to build additional small industrial units as per promoted SHELAA site CLID010. Parish Councillors emphasied the importance of natural screening plus environmental and biodiversity benefits as part of any proposal.

### **6.4** Neighbourhood Plan Update

Volunteer needed to compile evidence base for 'Heritage'.

### **6.5** Stanhd Update

CPRE continues working on the case for valued landscape to take to BDBC. Much expertise is being offered at minimum charge but funding is needed. Noted that CAGE (Clean Air Green Environment) has been active in opposing the warehousing / distribution application for north of Junction 7.

**Yision for Land north of J7'** published for public consultation.

A full discussion on both the surface water problems on the roads around the centre of the village and the pond and its outflow took place. The outcome of the discussion is listed below with agreed action points.


### **Surrounding Roads**

- 1) The PC will prepare a map with the approximate location of the current Grips (SB/ST)
- 2) HCC will look at the cutting of new grips up Northgate Lane towards the school to help to reduce the flow of water down towards the pond. (AW)
- 3) HCC will ensure the current grips on Farleigh Hill are maintained (AW)
- 4) HCC will see if the drainage report of the gullies and pipes around the pond can be shared (AW) DONE


#### **Pond**

- 1) PC will circulate a copy of the report on the pond and its surroundings prepared by SB in September 2019. (ST)
- 2) SB will update the report including the major flooding in the summer of 2020. (SB)
- 3)a HCC will clean out the silt traps three times per year <del>and will let the PC know the dates on which it will occur so parking can be managed</del>. (AW)
- 3)b Parish Clerk to submit an enquiry on HCC web pages to be directed to the gully cleaning service team at HQ asking what prior warning of the gully cleansing vehicle arriving might be possible. (ST)
- 4) PC will work to record instances of internal flooding in the village and the number if times it has occurred. (AT)
- 5) PC will prepare a note for the newsletter asking residents to do "their bit" in reducing the surface water reaching the local roads. (ST)
- 6) PC will send AW a copy of the water quality report for the pond (ST)
- 7) HCC will write to all occupants of houses which have the pond overflow water course in their gardens explaining their responsibilities. (PP)
- 8) HCC will consider a survey with the PC, of the water course to understand where it runs and how it might be improved (PP/ AT)
- 9) PC will wite to Anna McNair Scott about the pond. (AT) IN DRAFT
- 10) HCC noted that as a result of the survey undertake in the autumn, the pond problem had been added to "Operation Resilience" but no date as to when it work might take place was known.
- 11) The pond liner was discussed and no acceptable reason for it being there could be made from a water management standpoint.

- <u>20/03197/PIP</u> (Pending, Validated 19 Nov 2020) Permission in Principle for erection of 2 no. dwellings. Land Adjacent 14 Hackwood Lane. *PC comments submitted.*
- <u>T/00594/20/TCA</u> (Approved 4 December) The Mount, Farleigh Road, Cliddesden. Leylandii: crown reduce to approx 14m. 'PC response no objection'
- <u>20/02907/HSE</u> (Granted 14 December) 24 Southlea, Cliddesden. Erection of part single storey, part two storey rear extension with single storey front infill extension, porch canopy, internal alterations and changes to fenestration. *PC response: No objection.*
- T/00547/20/TCA (Approved 17th November) The Well House, Farleigh Road, Cliddesden.

  Reduction of the Beech tree canopy radius by 2m leaving a finished radius of 4m on the east, north and south side. The west side of the tree has already been heavily cut back which is currently enhancing its lean. The proposed work will rebalance the weight distribution and minimise further leaning. Height reduction from 18m to 13m approximately. Reduction of the overhanging branches on the east side to give a 2m clearance from the building. The Parish Council have raised no objections to this and correspondence can be found in the supporting documents section. The applicant and neighbour are very worried that the tree is unstable and may fall, therefore we are requesting a fast-track of this application. *PC response: No objection.*
- <u>T/00532/20/TCA</u> (Approved 26 Nov) Mentmore, Farleigh Road. Fell 1 Fir. Response *PC response: No objection in principle but can't be seen from road'.*
- <u>T/00538/20/TCA</u> (Approved 25 Nov) Sorriso, Farleigh Road. T1-Lime located front of property, Reduce crown by 2m all round leaving an approx finished height of 13m with a crown spread (radius) of 5m. 'Response no objection to this work as long as it's carried out over the winter months.'
- 20/02450/HSE (Granted 18 Dec) 2 Coldharbour Cottages, Woods Lane, Cliddesden. Demolition of existing lean-to porch and construction of single and two storey extensions. PC Comment 2: 'The Parish Council's attention has been drawn to residents' concerns regarding the very limited access. To request that if the case officer is minded to approve any form of extension that conditions be made that the access be kept open at all times and any materials stored within the curtilage of No 2.'.
- <u>20/01799/HSE</u> (Granted 4th November) 4 Hackwood Lane, Cliddesden RG25 2NH. New description Erection of a detached garage/annexe. [Formerly Erection of a single storey rear extension following removal of existing conservatory, raising of rear part roof to create first floor living space and erection of a detached garage/annexe.]
- <u>20/01098/FUL</u> (Granted 18th Nov, DC of 11th Nov) Appleyard, Woods Lane. Erection of 4 no. dwellings with associated parking and access arrangements.
- <u>20/01168/FUL</u> (Granted 21 Dec) Greenlands Nursery, 3A Hackwood Lane. Erection of three detached bungalows.

#### **Old Basing Application**

<u>20/03130/FUL</u> (Validated 04 Dec 2020) Land At M3 Junction 6 From Junction 5 Off Slip Basingstoke Hampshire. Construction of temporary access road to enable construction of Basingstoke Motorway Service Area (Land At M3 Junction 6 From Junction 5 Off Slip)
