BOSP (Brighter Opportunities through Supported Play) is a South Essex based charity who have been supporting families for over 27 years. BOSP provides high quality fun activities with care for isolated children and young people aged 4 years and up who have complex disabilities or life-limiting conditions

We support 600 children and young adults with disabilities, parents and siblings a year

BOSP offers 8 regular clubs with a high ratio of Playworkers to child or young adult at evenings, weekends and school holidays

We deliver hall based sessions and community based out & about club activities throughout Essex and Havering

We aim to improve the children's and young people's independence, self-esteem, social skills and well-being, whilst providing families with essential respite in order that they can continue with their caring role

As a result of our work, of the children who attended last year:

-  100% of children and young people who attended learnt a new skill and had fun
-  97% experienced reduced social isolation
-  94% had increased confidence and self-esteem
