## 3. Minutes of the Meeting of 09 October 2019

Cllr Mrs Oxtoby PROPOSED that the minutes of the meeting of 09 October 2019 were signed as a true record. SECONDED: Cllr V Sewell and AGREED.

#### 4. Land and Site Maintenance

- 4.1 Hedge Cutting It was NOTED that the quotation of £320 plus VAT to face the Ash Road side of the hedge and to top and face the hedge between Northfield and New Ash Green has been agreed with the current contractor and falls within the 10% increase margin agreed at the meeting of 09 October 2019.
- 4.2 Countryside Stewardship It was NOTED that the application for the Mid-Tier Stewardship has been successful and we entered into a five year agreement from 01/01/2020 to 31/01/2024 with a yearly total of £1,852.86, the total agreement value is £9,264.30.
- 4.3 Matters arising from walk around Northfield it was NOTED that plants have been planted on the Northfield side of the boundary with the allotments without permission. Cllr V Sewell PROPOSED that a letter is sent to the New Ash Green Horticultural Society and a copy to the New Ash Green Village Association stating that permission should have been sought and any future planting should not be carried out without consultation with the Committee. These plants will have to be incorporated in our maintenance regime in accordance with our requirements.

Brambles – it was NOTED that the brambles spreading between New House Shaw and Barnetts Wood need to be cut back to keep the two areas separated. Cllr M Brown PROPOSED that Mr Glover carryout the cut at a cost of £45 per hour and report back to the committee. SECONDED: Cllr V Sewell FOR:3 AGAINST: 0 NO VOTE: 1

#### 6. Horse Riding Route

- 6.1 Review of Horse Riding Application Pack the review was carried out and a new regulation will be introduced stating that horses must be ridden or led by hand. PROPOSED: Cllr Mrs Oxtoby SECONDED: Cllr S Glover and AGREED.
- 6.2 A local tree surgeon will be asked to install different sizes of tree stumps to act as mounting blocks at the Church Road entrance. Once installed they will be covered with wire mesh to prevent slipping.
- 6.3 It was AGREED that the Horse Riding Route will re-open on 01 April 2020 dependent on the weather.
