Hoveringham Cemetery (Fees do not include Grave digging) 2023 (1st Jan)

THE TERM “EXCLUSIVE RIGHTS” MEANS FOR A PERIOD OF ONE HUNDRED YEARS

THE TERM “RESIDENT OF THE PARISH” MEANS LIVING IN THE PARISH FOR FIVE YEARS BEFORE DEATH.

If a former resident of the Parish has lived out of the Village for up to five years prior to death, residency rates can still be claimed. After this period of time has elapsed (five years), non-resident rates will apply

Section A

Rights of Burial

For exclusive rights of burial for 100 years in an earthen grave, of the body of a child under the age of five years, whose parents are residents of the Parish at the date of death, the child shall be buried in ground appropriate – no charge shall be made **£ NIL**

For exclusive rights of burial for 100 years in an earthen grave of the **body of a person** who is a resident in the Parish at the date of death whose age at the date of death exceeds five years **£ 550**

Non-resident of the Parish **£ 990**

SECTION B

Interment (exclusive rights purchase is required for all interments)

For the body of a child under the age of five years whose parents are residents of the Parish **£ NIL**

For a person **resident** in the Parish whose age exceeds five years **£440**

For a person **non-resident** whose age exceeds five year **£770**

SECTION C

Cremated Remains

For exclusive rights of burial in an earthen grave of the **cremated remains** of a resident in the Parish in ground appropriate

Resident of the Parish **£220**

Non-resident of the Parish **£330**

The cost of interment shall be equal to the cost of exclusive rights of burial

For interment of cremated remains, the undertaker shall arrange for the plot to be dug and filled and for any memorial to be placed.

SECTION D

MEMORIALS and MOMUMENTS

For the right to erect on a grave for the period in which exclusive right has been purchased,

I)	Headstone (as approved by the Parish Council maximum height (0.91m)	£220
II)	Vase (memorial)	£110
III)	Memorial plaque affixed to brick wall (maximum size 0.3m x 0.3m)	£165
IV)	For additional inscription	£NIL
V)	Tablet (maximum size 46cm x 46cm) cremated remains,	£165
VI)	The following are not allowed – Kerbs, surrounds or mounds	
VII)	No Wooden Crosses except on a temporary basis to mark the grave, whilst waiting for a permanent Headstone	

SECTION E

MISCELLANEOUS FEES AND CHARGES

i)	Scattering of ashes in the Garden of Remembrance	£Nil
ii)	For registering Deed of Grant of Burial	£Nil
iii)	For transfer by succession or otherwise Deed of Grant	£Nil
iv)	Parish Council to buy back Deed of Grant at original price paid	
v)	Search fee	£27.50
vi)	Exhumation	£440
vii)	Re-open (second burial in family plot as in sections B)	£275
viii)	Shrubs, Plants and Trees are not allowed without the P.C consent	

SECTION F

OTHER CONDITIONS

To Funeral Directors

- i) The Parish Council does not dig graves
- ii) All graves shall be to a minimum of 2 metres x 1metre or in the case of cremated remains 61cm x 61cm, The Parish Council will arrange to measure the plot.
- iii) No raised mounts
- iv) Fees to be paid in advance, cheques payable to Hoveringham Parish Council

The Fees which shall be payable are as follows:

For burial and interment (where exclusive right of burial **has not** already been purchased prior to death):
the total of sections A+B.

For burial and interment (where exclusive right of burial **has** already been purchased prior to death):
section B.
