## Minutes of the Council Meeting held on the Tuesday 1<sup>st</sup> March 2022 at the Thorncombe Community Centre, commencing at 7.30pm

Present: Cllr's J Higgs (Chairman), A Hiscock, D Marsh, and P Basham

**In Attendance**:-The Clerk (Mr J Vanderwolfe), Cllr S Christopher and seven members of the public.

| 491 | Apologies An apology had been received from Cllr M Stead due to having been called out to work. Agreed to accept this apology.  |

| 492 | Declarations of Interest There were no Declarations of Interest made at this stage of the meeting   |
| 493 | Minutes The minutes of the meeting held on the 1 <sup>st</sup> February 2022, having been previously circulated, were agreed as a true record.  |
| 494 | Matters Arising Cllr D Marsh reported that he had investigated the solar panel offer being offered between Eon and Dorset Council and found it to be worth pursuing. This was noted.  |
| 495 | Democratic Period  The chairman informed the meeting that he had run the surgery in the Community shop yesterday. A parishioner had voiced concerns about the state of the roads in the area and had been informed that there were a number of scheduled works to be undertaken in the parish. Concerns had been conveyed regarding a large amount of vegetation on the footpath by Yawlings. This matter was being dealt with by a Footpath Warden. Cllr P Basham volunteered to run the April surgery.  Cllr Basham spoke about the implications of the power cut on the community shop and that it had been suggested that a generator be purchased. Someone had suggested |

that the parish council might provide some financial assistance. It was agreed that more information was required and that a formal request with costings would need to be made for consideration. There was a discussion regarding the fact that BT were planning to discontinue digital telephones. If this was the case there was a need for a backup plan. Cllr A Hiscock stated that he had dealt with the transfer of phone networks in a previous job, and therefore agreed to look into the options and report back.

A parishioner spoke about the state of the roads near to Forde Abbey stating that she had been informed that the big problem was the number of springs in the area. It was however understood that the road was due to receive some major works in the future.

A resident complained about the unsightly appearance of the former telephone box whilst it was being refurbished. Whilst she was assured that this was a temporary thing, and that it would be completely refurbished, she requested that it be removed until that work was due to take place.

A resident spoke in relation to the Magdalen Bungalow planning application which had been dealt with at the February council meeting. He stated that although he was a neighbour of the application he had not received any notification, although did state that a notice had been displayed on site. He also stated that he felt there were a number of inaccurate statements within the application and that the plan was incorrect. He noted that our planning committee had visited the site and was surprised that the council had agreed to support the application. He felt that there would be major problems with soakaway if Dorset Council were of a mind to pass the application. Cllr Hiscock explained that whilst this council had supported the application it would be down to Dorset Council to determine the application. Any problems with items such as soakaways would be dealt with by the Building Control Section. It might well be that Dorset Council would impose conditions on the application. He also informed the resident that the parish council only has a short timeframe to examine the planning application and make a response. He made the point that residents have the right to convey their concerns relating to this application to Dorset Council via their planning portal.

A number of residents spoke against the planning application to extend the quarry at Westford Park. They made the point that the previous application had been refused by Dorset Council. This application had received a support from South Somerset District Council in relation to the provision of mineral extraction. A gentleman went on to explain that some residents had paid for a report to be prepared by a Quarry expert. The point was made that if this application was passed it would open up the valley and that it would be seen by all around. He made the point that this was in an AONB area. A resident who lived very close to the intended extension of the quarry stated that there would be continuous noise and disruption for the life of the quarry. She felt that this was unacceptable. Members of the public noted that the parish council had supported the last application but urged them not to support this application.
