067/1718 PUBLIC SESSION

Ref 17/05812 and 17/06157. Emily Robinson PWA Planning Euro Garages (not ref 17/05812 as does not act for Jaguar Land Rover). Gavin Highways consultant. Hybrid. To west = garage, to east = outline for offices. Concurrent Jaguar Land Rover have also applied for site next door (not acting for Jaguar). Whole site owned by Euro Garages. Part of allocated site for extension to business park. Doing further work for Highways England. Roadside services will create circa 45 jobs. Offices jobs unknown yet as outline. Cllr. Wild asked to be consulted as ward councillor as Shrewsbury councillors had been spoken to but not her. Land around the pool deemed undevelopable at present due to condition of the land. Adjoining landowner had come to ask what would happen to this land.

Access off roundabout. Will have cycle lanes through remainder of the site. Parking is higher than what was approved/constructed for the original park to satisfy concerns of Shropshire Council, given that this is an edge-of-town location. Car dealership to have its own priority junction closer to Emstrey roundabout for customer access. Car transporters will go in off the roundabout at the rear of the site. No access for lorries to fuel station – just for light vehicles. Intensity of use with service station from highways perspective is less than if whole site was offices. Developer is liaising with Highways England re Emstrey roundabout.

18/00111/FUL – diversification of farm. Free range hen laying units. Application is in Berrington PC. 40 acres. Sited outside of the main village. No neighbour objections. Shed is 110 metres by 26 metres. Egg collection every 3 days.1.8 metre high perimeter fence in chicken wire mesh plus electric fence. No external lighting. Finish on the shed to be determined by planning. 2 acres of tree planting. Chicken muck will be recycled into fertiliser on site.
