PUBLIC INPUT AND OTHER BUSINESS		
Discussion	<p>The trees bordering St Mary's Close and Hillcroft, Vicarage Lane were still getting overgrown.</p> <p>UK Power Networks had recently cleared some branches in Vicarage Lane and had cleared the branches.</p> <p>The NVE thanked Beechgrove for their invaluable help in organising carparking for the recent firework display. Over 3000 people attended.</p> <p>The field opposite Prima had been used for access to steal from sheds etc. and the farmer had now put a padlock on the gate on the footpath while waiting for a new gate to be installed. The PC agreed to pay half of the cost of a new gate £74</p> <p>The Cricket Club were applying for new practice nets which would require planning permission and asked for the PC to support the application. The PC agreed.</p> <p>There was a lengthy discussion regarding the village hall windows which were rotting away rapidly. Over £30k was needed to replace them. A previous application to DDC Planning for replacement PVC Prima windows was turned down so wooden ones needed to be made. Grants had been applied for.
