10. Grant Application – Wild Flowers For Bowls Green

The clerk had applied to the WCC Councillor's Grant Fund 2023-24 for £350.

It will be towards the end of January before we know if the application has been successful

11. Trophy For Cricket Club

The cricket club approached the PC about providing a trophy to be known as the David Waithman Trophy which could be presented to a player. This would be a fitting memory to David's love of Cricket and PH agreed to find out how much a trophy would cost.

12. Christmas Lights - additional costs

It was agreed that the Parish Council would cover the additional costs of the Christmas lights and the refreshments.

Nigel Willmott to be reimbursed for £49.92 for batteries and tree lights.

Gary Hunt to be re-imbursed for ££265, being £165 for additional lights and £100 for the use of a cherry picker . Dilys Cox £39.02 for mince pies and mulled wine.

This was proposed by MR and seconded by SW. Agreed unanimously.

The cost of the lights this year will be offset by savings made in future years. The lights will remain permanently on the tree and so there will no longer be any need to buy a Christmas tree in future years. Histrorically this cost £160 annually. The switch on was well attended and attracted a lot of new people. Feedback received was very positive and the event was deemed a success. The Parish Council are optimistic that it will be even better next year. There will be a de-brief with FONR.

13. Bowls Club House - Activities

A craft group organized by Helen Colclough has held an initial session in the clubhouse and it was well attended. Consideration will need to be given to future use pending any refurbishment needed to comply with Health and Safety regulations etc.

14. Goosewalk

To be started by GH as it is a Parish Council sponsored event. GH has done a Risk Assessment which the police requested. GH is to speak to Mike at the Queen's Head about making soup for the walkers. It is hoped that a map of the route can be included in News and Views. Marshalls will be needed .PH offered to help and will also ask FONR.

15. Playing Field

It is estimated that it would cost around £1000 a year to cut the field. This was previously done by David Waithman.

GH has met with Chris Haines from the Cricket Club. The cricket club will continue to use the field, but Chris Haines has agreed to cut the field. Chris is committed to developing ladies' cricket. There will be no matches played on Saturdays so the village hall is not compromised with their weddings and the parish council could explore possible income streams.

16. Duckpond

There is still no funding in place for this, but GH has asked Cllr Humphreys about Section 106 funds from Cameron Homes. A project plan is to be formulated and managed. The vegetation on the walls will be removed at the same time.
