# MINUTES of A MEETING OF PENTEWAN VALLEY PARISH COUNCIL held on WEDNESDAY 17 June 2020 HELD REMOTELY VIA ZOOM AT 7PM.

## (20/001) Apologies for Absence

# (20/002) Minutes of a Meeting of Pentewan Valley Parish Council held on \*\* 20 March 2020

It was resolved that the minutes of the Parish Council held on 20 March 2020 be signed as an accurate record of the meeting.

#### (20/003) Declarations of Interest on Items on the Agenda

Cllr Avery declared an interest in agenda item 14g, Pentewan Car Park. Cllr Avery had been granted a dispensation by the parish council to speak and vote on matters relating to the car park until May 2021.

#### (20/005) Public Participation

#### (20/006) Cornwall Councillors Report

Cllr Mustoe stated that we were in the 13th week of lockdown and while some more measures were eased at the beginning of the week, there is still a long journey ahead to any sort of return to normality.

Cllr Mustoe passed on his continued thanks to everyone in Pentewan Valley Parish, from the Parish Council, and the wider community volunteer and business network for everything they had been doing in keeping the area running during the COVID-19 pandemic, from assisting vulnerable people with food and prescription deliveries, to fundraising for PPE, operating social media support groups and changing work practices to be able to continue operating for the communities during lockdown.

Cllr Mustoe continued that while there are many people who have gone above and beyond at this time, he felt that a special mention must be given to the Chair and Vice Chair for their efforts in the parish during this time.

The speed and efficiency in which the COVID-19 relief efforts in Mevagissey Division were up and running and have since operated had been held up as exemplary across Cornwall and from conversations he had with other Cornwall Councillors and council officers that we have achieved an incredible amount, and continue to do so, for our communities at this difficult time.

Cllr Mustoe said that while the ways in which he worked as a councillor had by necessity changed during lockdown, in a number of ways Cllr Mustoe said he had

never been so busy.

His days typically were now spent dealing with a constant stream of emails, telephone calls and messages on social media on all manner of things. Cllr Mustoe said he had tried to reassure residents and businesses with queries about the COVID-19 crisis, the support available to them both nationally and through Cornwall Council, as well as using his own social media channels to quickly get the latest national and local guidance out there to enable to people to access whatever support is available as quickly as possible.

He went on to say that in terms of his 'regular' work, things had changed considerably in all sorts of areas of council life. To highlight just a few, the planning system has temporary changes added to it with the council not allowing site visits and determining so called 'contentious' applications via a process that has yet to be clarified. He hopes this system will be removed as soon as it is safe to do so. Cllr Mustoe went on to say that with regards to Cormac and the issues he regularly works on around the upkeep and maintenance of open spaces, verges, highways and footpaths, this work had been paused apart from emergency work, but has now restarted as of May, and he had a list of open spaces for cutting which has been passed on to Cornwall Council and is being gradually actioned. However, Cormac staff who he normally works very closely with who have been furloughed for rolling periods, which makes continuity difficult.

Finally, in terms of general Cornwall Council business, Cllr Mustoe reported that two formal council meetings had been held virtually since lockdown began, one of which was on 17 June 2020, that he attended and he had continued to meet informally with local councillors via Zoom, but he hoped they will soon resume regular formal meetings to allow that crucial aspect of council business to proceed. Cllr Mustoe ended by saying" These are difficult times and we will continue to get through this by working together and continuing to prove what a strong community looks like in adversity".

- 2. The whole scheme would require extensive excavation which will affect the environment and the wildlife in the area.
- 3. There is a lack of affordable housing within the overall scheme.
