GENERAL NOTICE OF REGISTRABLE INTEREST

I, ALAN HISCOCK

being a member, or co-opted member, of Thorncombe Parish Council, give notice in this form of those interests which I am required to declare under the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 and the Thorncombe Parish Council's Code of Conduct. I understand that I must also declare any interest of a 'relevant person' (*my spouse, civil partner or any person with whom I am living as a husband or wife or as if we were civil partners*), as defined by the Council's Code of Conduct




