ARTHINGWORTH PARISH COUNCIL Minutes of the Meeting held on Tuesday 5th July 2022

Arthingworth Camping :-

Mrs. Eva Tibbits contacted the parish council regarding a pop-up camping site on land at the edge of the village and attended the meeting to address concerns.

Comments received verbally by the parish council from parishioners:-

- The entrance will be very near to the Harrington Road junction and the corner of Kelmarsh Road and is also outside the 30mph zone. It should be noted that the entrance to the private cricket ground was of concern to Highways due to poor visibility.
- 2) It is noted that children and dogs are welcome on the site, There should be some consideration given to the inadequate boundary (a single strand of barbed wire on rickety posts) and ensured there are no safety hazards regarding the bordering stream and livestock in adjacent fields.
- 3) It should be ensured there is sufficient consideration given to the problems of rubbish, sanitation and noise.
- 4) The disturbance of wildlife should be a consideration.
- 5) Safety of campers is of concern given that there is no lighting or footpath between the site and the village. The campsite will be open during the harvest season and the area will have heavy farm traffic using the roads at all times, including when it is dark.
- 6) Some of the dates overlap with the Shambala festival.
- 7) Will the site be supervised?

The meeting was advised by Mrs. Tibbits as follows:-

- 1) There is a 28 day limitation on the use of the site
- 2) The site will be a small wild camping site only allowing tents and will have only 15 pitches.
- 3) The entrance is already used by farm traffic and should not be a problem
- 4) Site terms state that dogs must be kept on a lead or under control at all times. The landowners will remove any person from the site who does not comply.
- 5) There will be a 'beware of the water' sign on the boundary.
- 6) There will be a Portaloo on site which will be emptied regularly.
- 7) There will be bins (including recycling bins) on site
- 8) The site will have a quiet time between 10pm and 7am.
- 9) The site will be unlit but will have solar lighting by the Portaloo.
- 10) The village can be accessed from the site via private land therefore the until road will not have to be used.
- 11) The Shambala festival was not deemed to be a concern as tickets to the festival include on site camping.
- 12) The site will be visited twice a day by the owners and a contact number will be in the pub.
- 13) The area contains a wildflower meadow which will not be disturbed. There are no live badger setts in the area.
- 14) The site will never become full time as the land will be used for grazing.
- 15) As the land is uneven the number of sites will always be limited.
- 16) Only raised bbq's in safe areas will be allowed and the campers will be asked to leave no trace.
- 17) Cars will not be allowed on to the site but will have a small parking area on the right hand side behind the hedge.

Comments from the public:-

Concerns were raised regarding the application of a phone mast at the bottom of Hall Close. A discussion took place and Cllr. Irving-Swift updated the meeting on the issue.

- 1) The application is permitted development and may be difficult to stop.
- 2) The proposed land is owned by WNC.
- 3) Cllr. Irving-Swift made attempts to change the site but to no avail.
- 4) Only planning objections will be taken into consideration e.g.. It is an important open space (as stated in the N/hood Plan), the cabinets will be imposing, it will change the outlook of the village etc.
- 5) Opposition to the application possibly needs to be advertised in the media etc.
- 6) Cecile will contact the local MP.

Further comments:-

- 1) This will be a mast serving less than 100 houses with no previous complaints about poor mobile signal.
- 2) It would dominate the landscape
- 3) Children play in the area (the only green areas of the village)
- 4) The sight line of cars accessing Hall Close needs to be ascertained

Defibrillator:-

- 1) The defibrillator was purchased in July 2017 for £1477 (net of VAT) by the parish council. This was funded by donations from villagers.

- 3) A new battery was purchased and installed in July 2021.
- 4) The electrodes expired in December 2021 and a new set ordered. These are still not in stock and the clerk is making weekly phone calls to suppliers with no success to date.
- 5) The ambulance service has been informed and is aware of the "real challenge getting supplies of late".
- 6) The defib. is marked as 'not rescue ready' on The Circuit (the national defib. network).
- 7) Cllr. Irving-Swift has contacted WNC Director of Public Health
