62/23 Planning

23/01071/FULLS: Friar's Orchard, Rectory Hill, West Dean - Demolition of barn, erection of dwelling and installation of treatment plant [comment date 16th June]:

FC reviewed the previous application relating to this property which TVBC approved. The application is now subject to NDP policies - in this case NDP policy HD4 (design) is relevant. The roof is proposed to be of metal contruction (as present) but policy HD4 requires locally sourced materials to be used.

After further discussion FC proposed the submission to be "No object subject to conforming with NDP policy HD4 (materials used)". A vote was taken by show of hands: two voted in favour with one abstention. The vote was carried.

63/23 Consider approval to designate WT ACV Limited to proceed with the process to extend the Asset of Community Value (ACV) listing of The Black Horse Public House, West Tytherley

After a short discussion a vote was taken by a show of hands; it was agreed unanimously to designate WT ACV Limited to proceed with the process to extend the ACV of the Black Horse Public House.

64/23 Any other business

- Application from TVBC to divert FP3 from 28th June 2023. FC reviewed the situation.
- AP raised the issues around 8 Dean Road: the property is managed by Aster Housing and the tenant has vacated the property which is currently unoccupied. Neighbours have complained about the state of the property and it's gardens which are hazardous, particularly to children. Many requests have been made to Aster Housing to clean up the garden but no action has been taken to date. An abandoned car owned by the former tenant remains on the public highway along with a trailer filled with car parts and scrap metal despite many requests to TVBC Highways to remove.

It was agreed that Parish Council meetings will be held on the second monday of each month, including August, commencing on 12th June 2023. Henceforth meetings will start at 7.00pm unless otherwise advised.
