#### C/160/19. Chairman's items and welcomes

A member of the public asked whether she could talk about dogs on The Green and the Chairman said she would be invited to contribute during that discussion later in the meeting.

A resident from Ledburn raised the issues of poor telecoms in the village. AVDC District Councillor Cooper suggested she look at Connected Counties website and he said that Wingrave have been going through this process for five years and he offered to help her and her neighbours with this problem.
