Dear rec.cathey

There are serious problems (described below) on many of the rights of way around Waberthwaite that have persisted for some considerable time:

1. Bridleway "Bedelmere" (428022): mid-way along its length there is an extent of mud over a foot deep in wet weather, and still about a foot deep at present, even during this long dry spell of weather we are experiencing.
2. Footpath "Peggy's Lonning" (428013): normally impassable due to a large stretch of mud and deep water starting about 60 metres from the junction of the lonning with unclassified road U4058 101 (the road to Hall Waberthwaite church). Currently, after the dry spell we are having it is only passable with care.
3. Footpath from Broad Oak to Waberthwaite (428014): The bridge across Whitrow beck west of the Glebe is dangerous and in need of repair. It has been in this state for over a year.

Can you please advise when the LDPNA intends to put remedies in place?
