Suspension of meeting for Borough Councillor's report

The Chairman suspended the meeting to allow TMBC Cllr Martin Coffin to speak.

Cllr Coffin said that TMBC had already arranged heating fuel payments for nearly 32,000 households, with a small number of payments still to be made.

74 The new fingerposts had been delivered. Thanks went to Cllr Brooker for installing the fingerposts at what was a very busy time of year for him, and to Cllr Falconer for organising this. It was agreed that the Clerk should contact Zurich Insurance to

establish the cost of insuring the new fingerposts and signs against theft.

Due to work commitments, Cllrs Brooker and Saunders had not yet been able to move earth to build up banks in agreed areas; this action to be carried forward.

Cllr Falconer reported that a site meeting had been held with Claire Venner (KCC Highways), Highways Consultant Les Henry, and KCC Cllr Harry Rayner to discuss the next steps on the HIP (Highways Improvement Plan) for the three priority areas identified: Vigo crossroads, A20 junction at the Hilltop, Fairseat pond area.

Claire Venner said that at the A20 junction, all old road markings and cats eyes would have to be removed and the road surface made good before new markings could be added.

Claire Venner agreed that the Vigo crossroads was a problem area. She thought that the bus stops would have to be moved. She agreed to provide notes and indicate the cost of a topographical survey which would be required.

At Fairseat pond, an area of different coloured road surface had been suggested, but this would not be permitted by Highways. The parish council do not want white road markings here.

Claire Venner to provide notes and advise on next steps.

Cllr Brooker's solicitor had not been able to provide agreement documents for landowners giving permission for village gateways to be installed on their land. Cllr Sefer agreed to contact a solicitor.
