a member of the public raised the a question concerning the new Highways report for the development at Evergreen Barn

she was concerned that it still seemed to support the alteration of the junction of School Lane and The Turnpike

Mrs Godfrey was asked as the applicant if she wished to leave the meeting, but she said she would stay without taking any part

It was rediscussed, the opinions that were previously made, still stood now.

The fact that for years Highways have stated that nothing could be done to make the junction of School Lane and The Turnpike safer, but now having a planning applicant who wished to alter them, seemed to be going along with this. The PC have stated all along that narrowing the junction will affect all the roads on the crossroads

It was also noted that the entrance off of The Turnpike between the Village Hall and Veda Cottage would now be a footpath and it was proposed to put a barrier at the side of the road.

It was agreed that we would contact NSDC planning department and the case officer, confirming that the PC and members of the public are still against this development 5 for 1 abstention

St Michaels Close – Mrs Simmonds in formed the PC that on December 28th 2021sewerage was coming up the manholes outside the bungalows and Holbeck Cottage, it was cleared by a private firm. The blockage appeared to go all the way back to the church. The Chairman will contact STWA to find out why they didn't clear it
