Only one option has any impact on Carlton-on-Trent which is the dispersal option which allows 450 new homes to be built over 20 years between 61 settlements

Some concern about Growth scenario 4- this would amount to a loss of concentration of development in villages which may result in villages/hamlets losing facilities and services currently provided. This scenario would focus 70% of all new housing developments in Newark. If the Parish Council support Scenario 3- which could see Sutton-on-Trent's growth this would perhaps enable services and facilities to remain fairly local, yet could create more traffic issues for Carlton-on-Trent. After a lengthy discussion, all present agreed to support Scenario 3.
