MINUTES

- 1) Welcome by Chairman: The Chairman welcomed all to the meeting.
- 2) Present: Councillor C Wild Chairman Councillor L Picton Councillor S Mason Councillor C Bonsey Councillor R Ward Councillor R Purslow Councillor S Hawksworth: Apologies were received from Councillor H Roberts and Councillor M Howorth; Also Present L Pardoe clerk to the Parish Council, Richard Harman from Shropshire Council, Helen Howie from Berrys, Clive Benfield and Jonathan Westwood from Fletcher Homes; several members of the public (please see attached sheet)
- 3) Richard Harman from Shropshire Council to speak on the road layout and access relevant to the Application for the Planning Application 15/00539/OUT.

Richard said that the proposed new roundabout is a good level of improvement to the existing junction. The roundabout will be a significant object in the middle of the road with a 4" kerb face with some landscaping and signage on it.

It was agreed that the residents did not want additional parking for the shop on the opposite side of the road. Parking on the corner of the shop by the Atcham junction by large vehicles hampers visibility. It was agreed to ask the owner of the large vehicle to find alternative parking arrangements.

4) Helen Howie from Berrys and Clive Benfield and Jonathan Westwood to respond to questions from residents present on Application 15/00539/OUT

The question was asked if it would be possible to have a temporary access to the site for construction traffic .Mr Benfield said that to begin it would be off Holcroft Way until some houses had been sold to finance the new access. He hoped a separate site access could be constructed to alleviate construction traffic concerns of the residents. The roundabout would be constructed, and then Holcroft Way access on to the A458 would be blocked off after the construction of both phases was complete. (save for a pedestrian access)

- **5)** Representations from members of the Public. None at this point all questions were asked during the previous two speakers sessions on the agenda.
