- 7) Kelmarsh Road the edge of the road between Harrington Junction and Lodge Farm has broken down badly and is hazardous. Clerk to report
- 8) Kelmarsh Road footpath the work has still not been carried out. The clerk to contact DDC to ask when the work will be done.
