The Statement of Nominations has been received, and the Parish Council have an uncontested election with only 6 councillors standing. The number of councillors required on the council is 11 and we are looking for residents to join us. If you are over 18 years and live in the parish or within 3 miles of the parish, you are eligible to join. Please contact the Parish Clerk if you are interested in making a difference to your community.

It is great regret that we have to announce that we have had to cancel the Queen's Jubilee Tea Party on Saturday, 4th June. However, the Parish Council are supporting the Village Hall Committee with a grant of £200 to go towards the food for Barbeque which is being held on the same day.

The Parish Council will hopefully be getting a commemorative bench to go in the Borough, but this is subject to the National Trust's permission.

Apparently, our new fingerpost has already been hit by a delivery van parking outside the church. We would like to get a small planter to go around the base of the fingerpost, but we been informed by the Roads Records department at Somerset County Council that we would need a Section 115e licence which is quite costly. We still haven't received permission from the Highways department, so this is something the Parish Council need to discuss further.

Many thanks to our new Speedwatch team. All our volunteers have now been fully trained and carry out as many sessions as they can. Our team would benefit from a few more volunteers. We have just had some tree work carried out in the allotments as the trees were growing out into the trackway obstructing the access for allotment holders. The tree team at Streetscene have done a fantastic job tidying up this area.

We would like to thank the W.I. for their offer of a couple of trees for the allotments. It has been suggested that these are planted in the area behind the bus shelter.

We currently have three vacant plots so if anyone is interested, please let us know.
