# Draft Local Plan 2040 (Regulation 18 Stage 2) Public Consultation

Public consultation on the draft Local Plan 2040 (Regulation 18 Stage 2) has already started. This is taking place for eight weeks between Tuesday 6th February and Tuesday 2nd April 2024 (closing at noon)..





As you will be aware, the Council is preparing the next Local Plan for the Borough and is now seeking comments on its draft Local Plan. The consultation is your chance to get involved in shaping the future of the Borough. Details on how to make comments are available on page 4 of this issue. We are also undertaking a Call for Sites during the same period.

#### What is a Local Plan?

The Local Plan is produced by Test Valley Borough Council, in its role as the local planning authority. The Plan guides future development within the Test Valley area and covers a range of matters such as the amount and type housing and employment, land required to meet the community's needs, policies on the town centres, countering climate change. The Local Plan sets out how it intends to deliver sustainable development, whilst conserving and enhancing the local environment and heritage. It is used in assessing planning applications.

A Local Plan will go through several statutory stages of preparation which includes public consultation before it is examined.

## Why is the Local Plan important?

Local plans are important as they shape how places will change in the future. They can play a key role in helping to deliver local priorities, such as those identified by our Four Year (Corporate) Plan 2023-2027.

The Local Plan influences future changes within local communities. These changes can be on a wider scale, such as the location of new residential development across the borough or on a local scale, such as the parking provision on new development. If you and your community are seeking to influence the future of Test Valley, the Local Plan is the place to start.

# Where we are with preparation?

All Local Plans must be in accordance with national policy which the Government produces. Test Valley already has an Adopted Local Plan which looks forward to 2029 which provides the starting point for this one.

Three stages of public consultation have already been undertaken.

Issues and Options consultation (2018), Refined Issues and Options Consultation (2020) Regulation 18 Stage 1 (2022).

The next stage of preparation is the Regulation 18 Stage 2 document, which is a full draft

Local Plan.



#### **Consultation Process**

This draft Local Plan is at the Regulation 18 stage. The consultation document sets out the spatial vision and objectives for the future of Test Valley in planning terms. It sets out the level of new homes, jobs and infrastructure to be provided to support needs up to 2040 whilst also including policies on protecting the environment.

If adopted the Local Plan 2040 will replace the current Test Valley Revised Local Plan 2011-2029 which was adopted in January 2016

The draft Local Plan 2040 Regulation 18 Stage 2 will be out to public consultation for an 8-week period running from Tuesday 6th February 2024 to noon on Tuesday 2nd April 2024. During the public consultation period, paper copies of the draft Local Plan 2040 will be available to view at the Council's Offices (Beech Hurst, Andover and the Former Magistrates Court, Romsey) between the hours of 8.30am and 5pm on Monday to Thursday and 8.30am and 4.30pm on Fridays.

Paper copies will also be available to view at libraries during their respective opening hours at Andover, Romsey, North Baddesley, Lordshill and Chandlers Ford. A paper copy will be sent to all Councillors following the start of the public consultation period.

If you are unable to access the consultation documents, please contact us to discuss alternative arrangements. Officers are attending the Test Valley Association of Parish and Town Councils meeting on 7 March to provide an update on the draft Local Plan.

#### **How to Comment**

The new draft Local Plan for the period to 2040 is open for consultation for eight weeks, until 2 April 2024, following its approval at January's Full Council meeting

Residents, business owners and visitors to Test Valley will be able to comment on the proposals within the plan in a number of ways, including in writing, by email and through an online survey. Printed copies of the plan will be available at the council offices and libraries.

Respondents will need to provide their name and either a postal or email address. If they are responding on behalf of someone else, they will need to provide the name of the individual or organisation. Please note that emails are subject to a maximum 30Mb size limit, above which they will not be received.

Only those representations that are made in writing and arrive (in either hard copy or electronically) within the 8-week period between Tuesday 6th February 2024 and ending at noon on Tuesday 2nd April 2024 will have the right to have their representations considered.

The ASB Fund has been established to provide financial assistance to tackle persistent issues where CSPs (Community Safety Partnerships) and neighbourhood policing teams need extra support. It is focused on supporting local initiatives to address and prevent behaviours that disrupt the peaceful coexistence of individuals and communities.

The aim is to support local communities to make their environment a safer place to live and work. This local partnership has the potential to make a significant difference in the lives of its residents.

**Examples of Anti-Social Behaviour may include but is not limited to:** 

Vandalism and graffiti
Intimidation, harassment or bullying
Noise nuisance
Public drunkenness and disorderly conduct
Drug related activity
Environmental damage or littering
Hate crimes and discriminatory behaviour
Inconsiderate or dangerous driving
Applicants should note the following.

This funding will be provided to Local Authorities or Hampshire Constabulary. Applications can be from individual organisations but payments from OPCC (Office of the Police and Crime Commissioner) can only be made to Local Authority or Police from the ASB Fund.

Local Authorities will fund external suppliers and will be responsible for managing those arrangements.

## North and Mid Hampshire Safe Haven


