#### 22/22 Attendance from PCSO Marie Stabbington

- Marie introduced herself as our new lead PCSO. She joined the region in Sept 2021.
  She previously worked in the Avon & Somerset force for 19 years and has worked extensively in rural regions so is familiar with rural crime.
- She will be holding BEAT surgeries once a month dates and locations posted at the WT Village Shop. These surgeries will provide access to people and partnerships such as Age Concern. She will also carry out foot patrols.
- Email her if you need anything, however, she emphasised not to report crime directly to her as this would take her away from her duties. Crime must be reported using 101, online crime stoppers, or 999 if an emergency.

It's recognised placements need to be in areas with good access to public transport.

FC reported that a member of the public has contacted the Parish Council raising an objection to the Parish Council closing Agenda item 33/22. FC confirmed the Clerk had circulated the email to all Councillors prior to this meeting.

FC reported that the Clerk/RFO Melanie Camilleri had tendered her resignation on 14 February 2022. Her contractual one month's notice ended 13 March 2022, however, by special request from the Parish Council, MC has agreed to extend her last day of departure. Full details to be discussed and agreed.

As it would be difficult to limit the discussion of employment matters to areas that could be publicly disclosed without risking employer/employee confidentiality, FC proposed, seconded by JN and resolved unanimously that Agenda item 33/22 be closed to members of the public.

#### 33/22 HR matters

Matters unanimously agreed:-

- MC will continue in the role as Clerk/RFO until 30 April 2022. This was to principally carry out essential time critical tasks for the Parish Council e.g. the end of year accounts and audit. As MC is paid one month in arrears, her final salary payment date is 01 May 2022.
- The Parish Council will advertise for a new Clerk/RFO initially on a 3-month fixed term temporary contract, to be reviewed at the end of that term. The advert will initially be posted inviting applicants from within the local community.
