- 23.85 There were no **declarations of interest.**
- The minutes of the meeting held on the 11th of January 2024 were confirmed and signed.

23.87 **Adjournment Session**

After many years of service, the Chairman, John Mason has decided to step down from the council at the elections in May. This being his last meeting, John spoke about his time on the council and how much he had enjoyed it. Everyone agreed that he has been an excellent chairman and will be much missed. - 23.90 **Rights of Way:** DMMO Applications: No issues.
- 23.91 **Oborne Playground Equipment:** The damaged piece of equipment has now been renovated and reinstated.
- 23.92 **Fingerpost Repairs:** All the damaged posts have been repaired and the post in the centre of Poyntington has been repainted.
- 23.93 **Poyntington book exchange, kiosk maintenance** The wooden door of the kiosk is in a poor state and the council agreed to pay the costs of paint and filler. It will be painted by a volunteer
- 23.94 **Highways Issues**:
 - a) B3145 junction with Clatcombe Lane: The traffic collision officer has said that a larger mirror and collision warning signs will be installed quite shortly. Councillors were pleased to hear this but noted that the signs should be installed at the correct height.
 - b) A30 junction and pavement at Oborne: Councillors were pleased that the vegetation along the wall and on the footpath has been cut well back, giving a lot more space for pedestrians.
 - c) Sheeplands Lane, provision for horse riders: Cllr Dimond who was unable to be at the meeting had written to suggest that the council asks Dorset Highways to install extra road signs at either end of the one way system. The council agreed to do so.
 - d) Road and verge maintenance in Poyntington: The Community Highways Officer has offered to meet Mr Congdon to discuss the drains on Queen Street.
- Drains in Goathill: Cllr Buckland reported that Dorset Council has done some work to clear the drains. However, they are not planning to enlarge the drain on the north side of the bridge and have left a pile of road planings which are gradually being washed down the drain. The clerk had written to Canon Court Farm about the issue and received a phone call from Mrs Tizzard. They do not think that any of the gravel blocking the drains in Goathill is coming from Canon Court. However, they will make sure that the road is brushed whenever necessary after their contractors have used it.
- 23.96 **To consider and adopt updated standing orders** The council agreed to adopt the previously circulated standing orders based on the latest NALC model version.
- 23.97 **To decide parish council S137 donations for 2023-24** The council agreed to donate £100 each to the Air Ambulance and Sherborne Voluntary Ambulance.
- 23.98 **Parish Council Elections 2024** Nomination forms were given to the clerk who will deliver them to Dorchester. So far nobody has shown an interest in standing for Castleton.
- 23.99 **King's portrait for village halls** The clerk reported that free portraits of the King are available for parish councils. The council agreed that she should apply for one each for Oborne and Poyntington halls.
