## Keith has sent an update on Bramley Greener Homes

Four volunteers trained on domestic surveys, and four doing the thermal imaging camera training on 23<sup>rd</sup> September. We also have another three or four volunteers waiting for training.

The National Grid funding is tied to "Bramley", but this is not defined. We're using the Ward boundary as a limit, which means we can include Sherfield, Silchester etc.

We've tried various publicity methods: there is a flyer going in the Bramley mag next month, and we might do one in the Sherfield one. A drop-in volunteer rectruitment event the other day produced no usable takers. Posters and the like also don't work, but we are doing some paid Facebook inserts which may generate a bit of interest. We have just had the first two requests for surveys.

The next meeting is on **Wednesday November 8<sup>th</sup> at 4pm**, and there will be a short presentation and a Q and A session with Roderick McDonald, our Principal Conservation Office. Please can you forward me your questions beforehand and what you would like covered, so we can ensure everything is addressed?
