Location: Farm Buildings Near Scriventon House, Stockland Green

Proposal: Conversion of redundant farm buildings to 8 No. new residential units with associated

parking and landscaping and relocated access onto Barden Road.

#### 18/03458/FULL

Location: 3 Knowle Close, Langton Green, Royal Tunbridge Wells, Kent TN3 0EP

Proposal: Demolition of existing dwelling and erection of 3 dwellings, access and parking. Councillors briefly discussed this appeal and it was decided not to make any further comments.
