Christmas Tree

Planning

Many residents maybe aware that amended plans have been submitted for the application to land at Mason Lane, 20/00991/OUT, to reduce the number of houses from 30 to 17. This application was discussed at the Parish Council meeting, and it was agreed that despite the reduction in the number of houses, none of the material issues raised under the original application had been addressed. Therefore, the Parish Council still objects to this application.

Potential New Development

Councillors from Montacute and Stoke sub Hamdon were invited to an informal meeting with the developers of a second potential development of 55 houses in the parish of Stoke sub Hamdon along the Link Road to the A3088. Several issues were pointed out to the developers such as a significant increase in traffic through the villages, the joining of the two villages and that the schools and surgery were already at capacity and struggling to meet the needs of the community. The overall consensus of those attending was not in favour of another development and asked the developers to reconsider. If the developers do decide to go ahead with a planning application, there will need to be full consultation with the two villages which would include public meetings so everyone will get a chance to raise questions and get feedback.

FESTIVE RECYCLING AND WASTE COLLECTIONS 2021-22

Public holidays mean collections always change over Christmas and New Year and, with the festive period usually meaning more waste to recycle and dispose of, it is important that everyone knows their days so they do not miss a collection.

The revised schedule for recycling and rubbish is below. Every Somerset resident can check their collection days, for now and the rest of the year, using the My Collection Day feature on the somersetwaste.gov.uk website.

Usual collections resume

As usual, garden waste collections are suspended for two weeks after Christmas Eve to help crews cope with the extra waste that comes with the festive holidays. They restart on Saturday, 9 January – picking up collections that would usually have taken place on Friday, 8 January. Usual garden waste collections resume from Monday, 11 January.

All 16 of Somerset's recycling sites will be open at their usual winter hours throughout the festive period, except Christmas Day, Boxing Day and New Year's Day. They are a good option for disposing of large amount of recycling, such as cardboard, and will have special drop-off points for paper gift wrap.

NOTE: Only paper wrapping paper – minus glitter, tape and decorations – is recyclable and can also go in recycling boxes to be collected from the kerbside. Foil, plastic or glittery wrap cannot be recycled so needs to go in the rubbish bin.

If you have space, real Christmas trees can be composted or turned into a garden wildlife corner. Garden Waste Service subscribers can leave their <u>decoration-free</u> tree next to their garden waste bin for collection – so long as it is no taller than 6ft and its trunk no wider than 4 inches. Please try and do this within two weeks of the collections restarting. Everyone without a Garden Waste subscription will need to take their tree, decoration-free, to a recycling site and put it in a garden waste skip. They will not be collected from the kerbside.
