Minutes of the meeting of Stadhampton Parish Council (planning focus) held at the Village Hall, St John the Baptist Church, The Green, Stadhampton OX44 7UA on Monday 18th December 2023 at 7.30pm.

**Public Participation:** It was noted that participation should be kept brief, to enable the business on the agenda to be conducted in a timely manner. Correspondence received included:

- **Defibrillator owned by BP garage:** Agreed to contact the BP supervisor to discuss donation of the equipment to the Parish Council, subject to the cabinet being wall mounted at the garage (**action: Cllr Fitzgerald**).
  - **Letter from Bower Bailey solicitors:** They have been advised it will be an item on the January agenda.
  - **Request to land a helicopter on the village green:** refused due to suitability and safety concerns.
