72 (i) 21/01432/FL | Demolition of existing barns and their replacement for the erection of 3no. residential dwellings, together with associated garaging, parking, garden land and landscaping (Alternative scheme to Planning Permission TM/19/02607/FL: Proposed conversion, change of use of land, and associated works to form 3 residential dwellings) | Stansted Lodge Farm Buildings Tumblefield Road Stansted Sevenoaks Kent

Action point

Cllr Jack Saunders, having declared an interest in this item, left the discussion.

Following discussion, it was agreed that only minor changes had been made from the previous application TM/21/00285, and therefore the Parish Council objections submitted on that application should be reiterated, with additional comments: No scale or measurements are given of the scale, in particular the height, of the windows.

Changes have been made to landscaping, but clarification should be given of the ownership, maintenance, responsibility, and future division of the landscaped areas.

Cllr Jack Saunders rejoined the meeting.

It was noted that following Liz Guthrie's retirement, Simon Valente had been appointed as Tree and Landscape Officer.

The Clerk had asked for an extension to the cut-off date for comments, to allow this item to be discussed at the June Parish Council meeting.

Following discussion, it was unanimously agreed to object to this application, for the following reasons:

The application would mean the destruction of ancient woodland, and of many trees with TPOs in place.

Many trees have already been cut down or severely cut back, resulting in loss of screening of the site, and impacting the previously rural nature of this Green Belt area, and destroying wildlife habitat.

Furthermore, it was noted that major landscaping and hardstanding works were being carried out adjacent to the tree area T4 on the application plan, and the Parish Council was not aware that planning permission has been granted for any such works. It was agreed that the Clerk would report this separately to Enforcement for investigation.

> Further to this, the Clerk had contacted four other local builders to request quotes. One had replied, saying that they would not be quoting for new works until 2022 as their order book was full. The other three had not shown interest in providing quotes, it was thought that this was due to the remote off-road location and difficulty of access of the proposed memorial site.
