5. Previous Meeting Minute Approval

Minutes of the meeting held on Tuesday 15th March were agreed with no amendments. Proposed AT, Seconded PB.

6. Play Area – with members of public:

7 members of the public attended. Over the previous few months questions have been raised regarding when the play area would be completed including from Chris Loder MP who had been contacted directly. A repeat invitation to meetings was given.

Cllr. Jones ran through the history of the closure until present day following an inspection failure including the work completed by D. Gardner, purchase of wood chip, funding constraints, and, more recently, equipment from the S106 monies.

The quote from the Toy Barn for installation of the climbing frame and clearance of the old area was discussed. Installation of a fence was deemed to be no longer needed. Consensus was to install the new equipment in an area away from the old play area and to clear the old site at a later time. Clerk to arrange for payment of deposit once invoice received.
