MINUTES of the COUNCIL MEETING

2034 Apologies for absence

Apologies had been received from Councillors A Strong and P Whitworth

2035 **Any declarations of personal or prejudicial interest by members or the Clerk** P Shanks declared a personal interest in item 2048, Recreation Ground conifers

2036 To receive:

- 2037 **To approve the minutes of the Council Meeting held on 1 March 2010** Proposed by MB, seconded by MP and carried
- 2038 Matters arising from the minutes of the Council Meeting on 1 March 2010 2030 MB said he had written an article on dog fouling for Compilations 2033 The Clerk said that the Millennium funds had been received by the Council
- 2039 Clerk's report

The Clerk went through his report, which is at Attachment 1.

The Chairman said there was a possibility that the container for the gel flood bags could be stored at the Compton Swan; he would pursue and let the Clerk know.

2040 To receive an update on vandalism and anti-social behaviour (ASB) in the village

LM said that the last NAG meeting had been cancelled: the next was on 22^{nd} April. She had written – and sent to Compilations - an update on what had happened following the NAG identification of the 3 priority areas of speeding, anti-social behaviour and vandalism in Compton. Her report is at Attachment 2

2041 To consider the results of the Young People's Activities Questionnaire

LM referred to her report – which is at Attachment 3 - but not all Councillors had received it, so LM was asked to circulate it. The Clerk was asked to put this item again on the next agenda

2042 To receive an update on the closure of the Institute for Animal Health

There was no further information

2043 To consider quotations received to improve the track that runs from Burrell Road to the Recreation Ground alongside the Village Hall (S106 grant of £11,776 available)

The Clerk said that 3 Parish Councillors (DA, BE and LM), himself and D Morris from the Village Hall and met Darrel Smith of TL Contracting last Friday. They had:

- Reviewed the scope of the quote received to improve the track and the car park and had asked for a new quote to include edging around the car park (except by the MUGA) and a larger area of car park.

- Requested a separate quote for resurfacing a 3-metre wide track along the back of the Village Hall to the eastern end of the compound and a 2-metre track running from it to the gate used by the playgroup children.

D Morris had contacted the Manager of the Day Centre who had said the Centre would close during the duration of the resurfacing work and they would like 1 month's notice of the dates to enable them to make alternative arrangements.

2044 To consider possible Highway safety improvements in Compton, given that a S106 grant of £23,500 is available

The Clerk said he was still awaiting a reply from WBC Highways concerning the possibility of the Parish Council purchasing and erecting speed signs; he was asked to chase WBC for a response. He was also asked to investigate the ownership of land at the front of Lowbury Gardens adjacent to Raceform, as Councillors were considering constructing a footpath there.

2045 **To consider the outline proposals by Sovereign Housing for developments in Fairfields**Councillors DA, BE and LM had attended a meeting at which Sovereign representatives said that they planned to demolish flats and garages in Fairfields and build new flats and 5-7 houses.

Sovereign will be holding an open public meeting when their plans are more advanced.

2046 To consider purchasing planters to stand by the new bus shelter and request the Scouts to maintain them

The Clerk was asked to contact AS to obtain her views on structure, design and costs so that a costed proposal could be brought to the next meeting.

2047 **To consider an application for a grant from Compton Community First Responders**Councillors considered that this was a worthwhile venture to support and MB proposed a grant of £200. This was seconded by PS and was carried.

2048 To consider recommendations from WBC Tree Officer concerning the conifers on the Recreation Ground and consider a quotation to remove them

The Clerk said that he and DA had reviewed the trees that the WBC Tree Officer had recommended be felled and there were 16 in total. Following discussion, KS proposed that the trees be felled; this was seconded by BE and was carried.

DA had approached one possible contractor who had provided a quote and a specification of work he would carry out. It was agreed that the spec should be enhanced to include 'grinding out all stumps' and the Clerk was asked to seek a re-quote and obtain 2 more quotations.

2049 To consider sending a letter of complaint to West Berkshire Council concerning the state of Byway 2

As AS, who was drafting this letter, had been unable to attend this meeting the item was carried forward to the next meeting.

2050 To consider making an additional grant of £200 to Compton Bananaz to meet special additional expenditure

PS proposed the motion, which was seconded by MP and was carried.
