| Advisory Committees ⁵ | <ul style="list-style-type: none"> • Non-councillors can be members • Sub-Committees can meet in private. • Full Council can receive detailed advice, speeding up decision making. • All Councillors feel involved in the decision taken. | <ul style="list-style-type: none"> • Decisions can't be made, only suggestions given to Full Council or Committee. • Subject to review requirements as above. • Meetings must be public and subject to notices, agendas and minutes. (Where not a Sub-Committee) • Must be Quorate as per SO. |
| Working Groups | <ul style="list-style-type: none"> • Not subject to public meetings, notices, agendas, or minutes. • Council or parent committee establish TOR. • MOP can be members. • All advice is reported to Council or Committee. • Officers are not required to attend. • Wine can be involved. | <ul style="list-style-type: none"> • No decision-making powers. • Proper Officer can follow the advice and make a decision. • No TOR are required. • Not subject to Quorum requirements. |
