## 20/12-4 To consider the accessibility statement for the current website

### 20/12-5 To consider the quotes for a new Parish Council website to comply with WCAG 2.1

DW thanked the working group for the extensive work on this topic. A report on the quotes gathered and those recommended by the working group was circulated.

AB reported on behalf of the working group, the recommendation is for the Hugo Fox web designer using their free template site, this is used by many parish council's. Also to purchase a .gov.uk domain and email package from Freethought at a cost of £90. PJ supported the free option. MU supported the process and agreed with the proposals. AD thanked the working group for the reports and works. DW commented on the DAPTC option to have a shared website space with lots of other Parish Councils being a good idea but given this option is free then this should be the way forward.

DW made the proposal to support the recommendations from the working group. DW suggested an amended proposal as the working group have completed the task the Clerk then takes this forward. KD supported this but raised a concern that the Clerk had not yet completed the initial website adjustments to PDF's and would she have the time, DW responded that if the Clerk was unable to find the time to carry out these tasks, she would report this to the Council.

# 20/12-6 To reaffirm the precept (if required) following the tax base information
